

STATE COMMANDER MESSAGE



23-24 General Order-04

PAGES 4 - 5 ARE TO BE READ AT MEETINGS THEN POSTED

MANDATORY:

General Orders: All material in the State General Orders is directive in nature and will be read to the membership at the Post regular membership meetings each month. <u>Some of these have remained the same and will remain for a while longer to instill their importance to our order. New Items will be added to the General Order and will have some highlighted in Red areas.</u>

ARTICLE X - RULES OF ORDER

Sec. 1001 - Rules of Order Governing All Meetings.

25. The dispensation and/or consumption of alcoholic beverages or use of smoking/vaping products in VFW

meeting rooms during VFW meetings are **prohibited**.

Post Commanders: If you, your Quartermaster, or Adjutant do not have an email address please designate a member of your Post, with an email address, to disseminate information from District and Headquarters. Also, please ensure the Post roster is always up to date and accurate.

Article I, Sec. 103 - Election.

Applications. After the applicant has filled out the application card, it should be provided to the Post Adjutant or Quartermaster, together with the dues (and admission fee, if applicable). A receipt shall be given to the applicant.

An applicant may be recommended after eligibility has been fully determined by the Post Reviewing Committee. With respect to a Department Member-at-Large, the National Organization and/or the Department Headquarters will be responsible for eligibility determination.

The original application of every member will be retained on file with the Adjutant. **Balloting on Applications.** Before voting on the application during a Post meeting, the Commander shall allow the members present an opportunity to state their objections, if any, to the admission of the applicant. Unless one member present shall request a written ballot, a vote shall be taken and a majority of the votes cast shall decide acceptance or rejection of the application.

WEARING OF HATS: Attention of Commanders, at all levels, are directed to action of the National Council of Administration prohibiting the wearing of VFW sport caps and/or western style caps at VFW meetings in place of the regulation cap of the VFW official uniform as set forth in the National Bylaws and Manual of Procedure Article VIII, Section 803; Cap. A cap of the overseas type, lettered with VFW initials, Post numerals, state, rank of office (when applicable), and bearing the Cross of Malta emblem, shall be the regulation cap to be worn with or without the uniform. The color shall be green, shade 51. Lettering on each cap shall be in gold.

Organizational echelons will be designated by the color of the braid (piping) and letters on the caps as follows:

Post officers, members and Past Post Commanders -- gold braid; County Council officers and Past County Council Commanders -- bright blue braid; District officers, except District Commanders and Past District Commanders -- bright green braid; Department officers and Past Department officers, Conference officers and Past Conference officers, and District Commanders and Past District Commanders -- bright red braid; National officers and Past Commanders-in-Chief -- silver braid.

The National Council of Administration may designate other colors or color combinations of the cap, braid and lettering to be worn on the caps of All-American and All- State honorees, life members and aides-de-camp. Past Commanders-in-Chief and National officers with a Council vote, other than National District Council Members, may wear white caps with gold lettering and braid.

Regulation caps shall be worn by elected and appointed officers at all official meetings. Uniforms. Subject to the approval of the sponsoring units, color guards, drill teams and similar units may adopt optional uniforms and campaign hats, berets, helmets or other headgear for wear at parades, assemblies and similar events and at official functions in the performance of duties. Headgear shall be uniform for all members of the unit. If organizational emblems are worn on VFW Color Guard Headgear, one of them must be the Cross of Malta.

and VFW Ritual;

General Rule 13, (a) All members who are able will stand during the offering of the prayers; (b) members will follow the action of the Chaplain or presiding officer relative to removal of caps during prayers; if uncovering, the hat shall be placed on the extended closed fingers of the right hand in such a way that the Cross of Malta is exposed and held over the heart; (c) official caps will not be worn during luncheons, banquets or other meals; (d) Official caps will be the only head covering allowed to be worn at regular meetings of the Veterans of Foreign Wars of the United States.

STATE SR. VICE COMMANDER'S MESSAGE


I hope this article finds all of you well. I look forward to seeing many of you at your post and district meetings. I will be attending meetings to learn more about my fellow comrades and determine if I can help you in any way. Please let me know if you have anything that I can help do. If any of you are interested in serving on a committee at the state level, now is the time to let me know.

By now each of you should have submitted for your post bonds. According to the By Laws, it is not just your Quartermaster who needs to be bonded. The Bylaws state that "Each officer accountable for funds or property pursuant to any provision of these Bylaws shall be bonded with an indemnity company as surety in a sum at least equal to the amount of the liquid assets for which, so far as can be anticipated, they may be accountable." I hope each of you have submitted all required bonds.

According to the Commander duties, commanders shall "Be an ex-officio member of all committees." What does this mean? The commander shall be a member of the committee and have the same rights as other members of the committee, unless your post Bylaws state something different. The same rule applies to the Chairman of the committee. Your Bylaws should determine if the Chairman is elected or appointed. If the Chairman is elected, then an elected officer cannot hold that position. If you have any questions about this rule, feel free to call me or another state officer.

Hopefully, all posts have sent requests for your Americanism, Patriot Pen, and Voice of Democracy to your schools (public, private and home), and other locations like local papers or social media. The due date for the program entries is 31 October to the post. Please check your due dates for district and state so you don't miss out on participating in the programs. If a student took the time to complete and submit an entry, we owe it to them to do our due diligence to get the entry forwarded to the next level. These programs are dear to my heart because if we don't teach students about patriotism and Americanism at a young age, we will lose the opportunity for them to learn.

Lastly, I want to discuss what commemorative dates the Bylaws tell us that each post shall observe. According to the Bylaws each post shall arrange to observe

Memorial Day, Veterans Day, Flag Day, and Loyalty Day, as well as commemorating other dates listed in the Ritual. The Bylaws also go into more detail about Memorial Day observances. The post should place suitable grave markers, wreaths, and flags on the graves of deceased members.

The main reason people don't join is they have not been asked, the reason they may leave is that they are not asked to be involved.

SUMMARY OF MINUTES NATIONAL COUNCIL OF ADMINISTRATION MEETING PHOENIX, ARIZONA Thursday, July 27, 2023

The National Council of Administration of the Veterans of Foreign Wars of the United States meeting was called to order by Commander-in-Chief Duane Sarmiento 1 hour after the adjournment of the National Convention, on July 27, 2023, with the opening prayer by the National Chaplain David Frei, followed by the Salute to the Colors and recitation of the Pledge of Allegiance.

Roll Call of officers and National Council members by Adjutant General Dan West recorded all present except for Council Member Jack Hawley (Montana) who was excused.

NATIONAL LEGISLATIVE COMMITYTEEMAN

Legislative Report September 2023

These are the key Topics from this month. Please read through these and let me know your thoughts on how we can continue to show Louisiana, that our Elected Officials are committed to our Veterans.

September 4th:

Progress Against Claim Sharks: New Jersey Governor Phil Murphy signed state legislation which makes it a violation of the Consumer Fraud Act for unaccredited individuals to receive unlawful compensation for advising or assisting with veterans' benefits. VFW Post 1333 in Neptune City hosted the law's signing. "Our veterans put their lives on the line in service to our country and have more than earned the benefits for which they and their loved ones are eligible," said Murphy. "We must protect veterans and their families from unscrupulous individuals who would take advantage of them by overcharging for assistance with those benefits. This legislation will help ensure these bad actors either follow all applicable federal standards or face the consequences." Read more.

Don't Wait to Apply for PACT Act Benefits: VFW Communications and Public Affairs Director Rob Couture, and VFW National Veterans Service Director Mike Figlioli participated in a Facebook Live event to discuss PACT Act benefits and eligibility. One clear message from the discussion was don't wait to apply for benefits or appeal denials from previous claim applications. Military service in areas covered by law from 1955 to the present that resulted in a diagnosis of a presumptive condition may result in compensation by VA. Survivors are also encouraged to apply as deceased veterans may have benefits that extend to eligible family members.

Access Vet Center Mental Health Counseling: Vet Centers offer free and confidential mental health and readjustment counseling in communities across the United States and its territories. While widely known as a resource for veterans, they also assist eligible service members and families. Available services include individual and group therapy, family and bereavement counseling, and referral assistance.

September 11th:

VFW Remembers 9/11: Today marks the 22nd anniversary of the terrorist attacks that changed America forever. The memories of that day are still vivid and raw in our nation's heart, but the heroism that emerged from the rubble of the World Trade Center, the Pentagon, and in the air above a rural Pennsylvania field should inspire Americans for generations to come. As we remember 9/11 and the nearly 3,000 innocent lives lost that terrible day, the VFW hopes all Americans pause to reflect on those we lost and those who continue to sacrifice in the defense of freedom.

September 18th:

VFW Fall Legislative Conference: The VFW National Legislative Committee members met with senators, representatives, and staffers in Washington, D.C., to discuss the VFW's legislative priorities. Specific focus was given to cracking down on predatory claims companies, consistent access to VA benefit enrollment for service members, and the role of economic opportunity benefits in helping to prevent veteran suicide. The VFW will continue to advocate for these issues to assist service members, veterans, and their families. Senate Confirms New

VA Deputy Secretary: The Senate voted to confirm Tanya Bradsher to be the VA deputy secretary. Bradsher is a 20-year Army veteran, and she will be the first woman to serve in this role. Senate Committee on Veterans' Affairs Chairman Jon Tester (D-MT) released a statement in which he commended her record of serving. As VA Chief of Staff, she oversaw the implementation of the PACT Act. Read more.

We are concerned with the number of schools that are opting out of VA education benefits, and will continue to monitor the situation. Watch the hearing, which begins at the 9:09 mark.

Prevent Benefits Fraud and Hold Bad Agents Accountable: The VA Office of Inspector General seeks your help in preventing Public Disability Benefits Ouestionnaires (DBOs) fraud schemes. These schemes include either unaccredited agents or unscrupulous health care providers charging unjustifiable fees with promises to exaggerate a veteran's medical condition to secure a higher rating than the evidence warrants. Know the signs and take action.



Flu Shots General Information

This information from the U.S. Department of Veterans Affairs (VA) is for Veterans and their families. This fact sheet answers some questions you may have about the flu shot.



Who should get a flu shot?

Everyone age 6 months and older is recommended to get a flu shot each year by VA and the Centers for Disease Control and Prevention (CDC).

Why should I get a flu shot?

- Getting a flu shot is the best way to slow the spread of flu from person to person.
- A flu shot can protect you and your family or friends against flu.
- Because of flu, thousands die and many more are hospitalized each year in the U.S.
- Anyone can get flu, but some people are at high risk for complications from flu:
 - people age 65 and older
 - people with health problems like asthma, diabetes, heart disease, chronic lung disease, and other chronic illnesses or conditions
 - pregnant women or people caring for an infant or a family member with health problems

How well does the flu shot work?

Studies show that getting a flu shot can reduce illness and death from flu.

When should I get a flu shot?

- In the fall, as soon as flu shots are available. A flu shot will protect you the entire flu season.
- Get a flu shot every year as flu viruses can change from year to year.

Why do I need a flu shot every year?

- EFlu viruses can change over time.
- Every year, the flu shot vaccine is updated to protect against the flu viruses most likely to spread that year.

Can I get flu from a flu shot?

No! Only inactive (dead) flu virus is used to make flu shot vaccine, so **you cannot get flu from a flu shot**.



Fast Facts: What is flu?

- Flu short for influenza is a respiratory illness caused by influenza viruses.
- Fu spreads easily. It occurs every year, mainly during fall, winter, and spring.
- Flu is different from a cold. People with flu usually feel achy and have a fever.

2023-24 SMART/MAHER VFW NATIONAL CITIZENSHIP EDUCATION TEACHER AWARD

PROGRAM. The Veterans of Foreign Wars wants to recognize the nation's top elementary, junior high and high school teachers (teaching at least half of the school day in a classroom environment) who teach citizenship education topics regularly and promote America's history, traditions, and institutions effectively through this program.

Now is the time to begin locating exceptional teachers for your Post to nominate for the next competition. All current certified/licensed teachers in grades K-12 are eligible. Previous national winners are ineligible. Nominations can be submitted by themselves, fellow teachers, supervisors, family members or other interested individuals.

All Post-level nominees should provide an entry form, a one-page resume as a minimum or up to five pages, including the resume, as a maximum of documentation of their teaching experience (for example: resume, references, news articles, etc.) and a head-and-shoulder photo of themselves, if available.

VFW Post Teacher Award chairpersons may submit one candidate, in each category (K-5, 6-8, 9-12), to their District by Nov. 15. If a Department does not have a District judging, then the Post winning entries would be submitted to the Department Headquarters and/or Department Chairperson by Jan. 1. The Department may select a single candidate, in each category, and submit them to VFW National Headquarters by Feb. 1 for National judging.

NOTE: The only item the National VFW Programs Department requires is the "VFW Department Teacher Award Citation Request Form" which will be available on the VFW website soon. You can locate this form by logging in to <u>vfw.org</u> and searching under "My VFW" in the Training & Support section.

VFW's Department Citizenship Education Teacher award includes a citation for both the winning teacher and their school.

VFW's National Citizenship Education Teacher awards include: three national \$1,000 awards for the top K-5, 6-8, and 9-12 teachers for professional development expenses; \$1,000 award to each winning teacher's school; plaques for both the winning teacher and their school; and an all-expense-paid trip to attend a VFW National Convention.

The new programs are as follows:

FRED C. HALL MEMORIAL AWARD FOR COMMUNITY SERVICE. Each year on July 1, the national Programs office will determine the top community service Posts in each conference, based off their community service reporting and total impact, from July 1 to June 30 the previous year. Your community service total impact is figured by the money spent to host and organize the community service event, plus total hours all volunteers participated, plus the mileage for all volunteers (Dollars Donated + Hours + Mileage = Total Impact).

These four Posts will be awarded the Fred C. Hall Memorial Award for Community Service and will be invited to attend the VFW National Convention. The Post Commander (or designated representative) and a guest will receive round-trip airfare, hotel accommodations for five nights, and a \$599 stipend to receive the award at the VFW National Convention.

OUTSTANDING COMMUNITY SERVICE POST OF THE YEAR. Each Department will have an OCSP winner based on total impact. National will select based on end of year reports on July 1. Winners will also be published in the Convention program booklet and receive a street sign identifying this national award for the Post to put up in their community.

"UPDATED" POW/MIA FLAG -- OFFICIAL DISPLAY DAYS. Under previous Public Law 105-85 (Nov. 16, 1997), it indicated there were only six days that federal agencies, military installations and U.S. post offices were required to display the POW/MIA flag. Now under new law, Public Law 116-67 (Feb. 21, 2020), it is required that the POW/MIA flag be flown on all days on which the flag of the United States is displayed. IRS AND VFW AWARD MONIES. The Internal Revenue Service (IRS) requires that any recipient that receives more than a \$599 award should receive a Form 1099 identifying the proceeds as taxable. This will include the VFW programs Patriot's Pen and Smart/Maher VFW National Citizenship Education Teacher Award.

"Buddy"[®] Poppy



"BUDDY"® POPPY CAMPAIGN. Although we emphasize Buddy Poppies on Veterans Day and Memorial Day, it is important to realize that the distribution of Buddy Poppies should be a year-round exercise. Each time a Post participates in an activity where the public will be present, Buddy Poppies should be present as a fundraising tool and simply to recognize our fallen comrades. Where the VFW appears, Buddy Poppies should be a constant reminder that we will never forget those who have perished in the name of liberty. Just as "They Gave, Will You?" is a year-round thing, so should the distribution of VFW Buddy Poppies.

Remember that your poppies should be ordered a minimum of three (3) weeks in advance of your distribution date.

BUDDY POPPY UPDATE: National Headquarters conducted a review of the Buddy Poppy policy and procedures and implemented the following changes effective Aug. 1, 2023:

- 1) If you do not receive your order within four weeks of placing it with your Department, please contact your Department Headquarters to report you have not received your order.
- If you do not report a missing order within 90 days of processing, the order will NOT be replaced free of charge, and you will have to resubmit your order.

Miscellaneous items (coin cans, buttons, posters, etc.) should be ordered directly from the VFW Store at <u>vfwstore.org/category/programs/buddypoppy</u> or the VFW Store/Emblem and Supply Catalog.

The Manual of Procedure provides that Post relief funds may be used for programs such as Voice of Democracy, Patriot's Pen, Citizenship Education, and Community Service as long as suggestions in the chairperson's guidebooks are used as an example of promoting these programs.

Posts are further reminded that Section 711 of the Manual of Procedure provides that non-profit organizations, exempt from taxes under Section 501(a) of the Internal Revenue Code, may assist with the distribution of Buddy Poppies, provided there shall be no division of proceeds. A donation to these groups may be made from the Post general fund.

VFW SILVER, GOLD AND DIAMOND ANNIVERSARY POPPIES. The silver, gold and diamond anniversary Buddy Poppies are for Posts that are currently in their 25th, 50th or 75th anniversary years. For Posts currently in their 100th year anniversary, they can order any color and as many as they need. Anniversary poppies are approximately three times as expensive for us to produce, but because of the small quantities we deal in, we do not pass those costs on to the Posts. Please limit your order of anniversary poppies to 1,000 to ensure stock does not run out unless you are currently in your 100th year. These are ordered through the Department and processed the same as the red poppies.

National Veterans Service

STUDENT VETERAN SUPPORT GRANT

The VFW recognizes that both funding and support for our student veterans and dependents at institutions of higher learning can often be difficult to find. The **VFW's Student Veteran Support Grant** offers much needed assistance to support specific student veteran events. The grant, administered by the VFW

Washington Office, focuses on supporting the overall student veteran population within the community, which consists of many student veterans at campuses across the country that are not affiliated with an SVA chapter. The grants will be disbursed to the VFW Post or Department that has submitted an application, to support the student veterans at the university or college.

Grant Eligibility:

- Applicants must be VFW members associated with an appropriate entity of the VFW (VFW Post, District, Department, or National).
- Appropriate VFW Post, District, Department, or National leadership serve as the convening authority on the grant request and is responsible for receiving funds.
- Funds must be utilized for events and outreach designed to assist and support veterans currently enrolled in institutions of higher learning.
- Grants may be awarded up to \$500 to support each event, and grants can be awarded to a VFW entity twice each fiscal year, totaling up to \$1,000.

National Legislative Service/Action Corps

VFW on Capitol Hill

The VFW National Legislative Committee members met with senators, representatives, and staffers during the VFW Fall Legislative Conference in Washington, D.C., to discuss the <u>VFW's legislative priorities</u>. Specific focus was given to cracking down on predatory claims companies, consistent access to VA benefit enrollment for service members, and the role of economic opportunity benefits in helping to prevent veteran suicide. The VFW will continue to advocate for these issues to assist service members, veterans, and their families.
