"Respect, Honor, and Prepare"



There are amazing stories to be told, buried deep within each and every one of us. Often, those stories come to light at funerals. Some of the most profound stories are concealed within the memories of our veterans. All too often the memories are

those coming from our family or friends left behind when our veteran has passed away.

On December 7, 2022, Navy Seaman First Class Houston Temples was buried at his hometown of Bogalusa, Louisiana. Houston died on December 7, 1941, eighty-one years earlier. Houston served on the USS Oklahoma; a ship destroyed in the attack on Pearl Harbor. At the funeral a niece of Houston's read from a letter written to his mother eighty-two years earlier: "Mama, mama, don't worry about me. I'm serving my country". There were many other memories shared by nieces and nephews that were passed on to them by their parents, Houston's brothers and sisters.

William A. "Bill" Thien was elected Commander-in-Chief of the Veterans of Foreign Wars on July 24, 2013, at the VFW's 114th National Convention, held in Louisville, Ky.

Mr. Thien served in the U.S. Navy from 1969 to 1974 and

served five years in the Indiana National Guard. His decorations include the Vietnam Service Medal with 3 stars, Vietnam Campaign Medal with 1960 Bar, Armed Forces Expeditionary Medal (Korea), National Defense Service Medal and several from the National Guard.

He joined the VFW in 1971 at Post 3281 in New Albany, Ind., where he maintains his Gold Legacy Life Membership. He has served the VFW in many leadership positions.

The stories were full of patriotism and honor for a sailor who was proud to serve his country.

Houston's remains were identified in November 2021 because a member of his family donated DNA. Anyone who has a family Veteran that has never returned home after a war should make a DNA donation. With modern technology we can identify those Missing in Action and bring them home to rest and give some closure to their families.

Throughout the year and throughout our state our VFW members and our Post Honor Guards gather to honor the passing of Veterans who very well could have written home at some point in their lives, "....don't worry about me. I'm serving my country". We should not be sad that they died but should be happy that they lived. There is always conversation at these funerals about the accomplishments of the deceased veteran and the pride for their military service.

Sometimes there is the unfortunate situation when a veteran dies alone with no family. But the VFW is family, and we should and do attend those ceremonies with honor and dignity.

We must do everything we can to bring our Combat Veterans into our Posts as members. We should try to learn their story while they are still living. We should be mindful of our elderly members who need assistance to attend our meetings and our functions. We should not let their membership lapse because no one is reaching out to them with buddy-checks. We should not wait until a funeral to share our veteran's amazing stories.

Keep up the great work of the VFW. I am proud to have served with you and to have learned many of your stories this past year.

Mr. Thien's VFW Positions include All American Post Commander, All State District Commander and All American State Commander. He has also held positions on numerous National committees, including Vice Chairman of Citizenship Education and Community Service and as Chairman of National Scholarship and Recognition.

In 1995, Indiana Governor Evan Bayh bestowed the honor of naming him a Distinguished Hoosier, and Governor Joe Kernan awarded Bill the Sagamore of the Wabash Chieftain in 2004. Kentucky Governor Steven Beshear commissioned him a Kentucky Colonel in 2012.

Mr. Thien attended Indiana University Southeast. He worked as a Team Leader/Shift Supervisor at Duke Energy and is now retired.

Mr. Thien is a member of the American Legion, DAV, Veterans of Vietnam War Inc., Military Order of the Cootie Pup Tent 51 and VFW National Home.

He and his wife Linda have four children and eight grandchildren. Bill and Linda make their home in Georgetown, Ind.

VFW AUXILIARY NATIONAL REP FOR THE STATE CONVENTION

Past National President Diana Stout of Charleston, W. Va., continues to serve the Veterans of Foreign Wars (VFW) of the United States Auxiliary as a member of the National Appeals and Grievances Committee.

Huntington Auxiliary 9738, she joined on the eligibility of her father, Thair Stout, who served in World War II.

As 2001-2002 National President, she led the membership behind the theme "Liberty and Justice for All," which is derived from her background in law, and one of the Auxiliary's main objectives: to maintain and extend the institutions of American freedom and equal rights and justice to all men and women. That theme took on added meaning in the wake of the September 11, 2001, terrorist attacks. Auxiliaries throughout the country reacted by providing personal care packages, donating thousands of dollars to help the victims' families, and providing \$280,000 for Operation Uplink™, giving long-distance telephone cards to servicemen and servicewomen.

During her term, the \$3 million mark was topped for the 14th consecutive year in the Auxiliary Cancer Aid & Research Fund; two Postdoctoral Cancer Research Fellowships in the amount of \$50,000 each were awarded; the National First-Place Young American Creative Patriotic Art was featured on note cards and funds raised went into a newly-created escrow fund.

Diana held many offices for the organization. She was named Outstanding Department President in 1986-1987 and served seven terms as Auxiliary President and two as District President. She was Department Secretary for three years and is currently Department Treasurer. She represented West Virginia and Virginia on the National Council of Administration. She also was National Chairman for the Southern Conference on the Publicity Program, twice on the Legislative program, and served as National Legislative Director in 1988-1989.

Stout is currently employed as the General Counsel of the West Virginia State Treasurer. She belongs to the American Bar Association, West Virginia Bar Association, National Association of Bond Lawyers, Government Finance Officers Association, National Association of Public Pension Attorneys and Kanawha County Humane Association.

Reminder: THE VFW Department ByLaws state that EACH Member in good standing will receive a copy of the Louisiana Combat Veteran.

ARTICLE IV
Revenue and Funds

SECTION 1. Department Dues

Department dues of seven dollars (\$7.00) per annum shall be assessed on each and every member in good standing in each and every Post in the Department except life members, which shall include a year's subscription to the LOUISIANA COMBAT VETERAN, the official organ of the Department.

GENERAL ORDERS

- **1. Attention Post Commanders:** All general orders should be read at your meetings and filed in post files for future references. General Orders will also be on the Department website listed above.
- 2. TAXES: An annual income tax return (Form 990) is required for each Post exempt from tax under Section 501 (c) of the code. If gross receipts (Gross receipts include from all sources, including membership dues, liquor or restaurant receipts, etc.) some of this may be unrelated business income in which case filing of Form 990-T may be required are \$25,000 or less the Internal Revenue Service requests only the heading on page 1 be completed, being sure to check Box B, and send it to the IRS center in your area. This must be filed on or before the 15th day of the fifth month after the end of the Department's Fiscal Year.
- **3. DUTY OF POST COMMANDER:** Section 218 of the Manual of Procedure, Duty of the Post Commander, requires that the Post Commander shall see that the Post Trustees Reports of Audit are properly prepared and submitted each quarter.
- 4. ARTICLES OF INCORPORATION: Post must have Articles on file with the Secretary of State are reminded that they have must file the annual report each year. If a Post fails to file the Annual Report and pay the \$10.00 fee -- the Post Article of Incorporation become INACTIVE and Post must reactivate the Article of Incorporation at a fee of around \$75.00.
- 5. VOTING: In accordance with VFW By Laws, Article II, Sections 221 Voting: VFW members present at a regular or special meeting determines the governing duly made and approved votes on the working order of the Post. Post membership has the final say on the working order of a VFW Post and canteen, unless Post ByLaws voted and approved indicate set rules
- 6. **RESOLUTIONS:** Are proposed and approved by a Post then by District before being forwarded to the Department thirty days prior to State Convention for delegate action.

- 7. NOMINATIONS AND ELECTIONS: Post nominations are in March and Elections are in April and election reports must be completed by April elections and forwarded to National and the Department immediately. Attention is directed to Section 217 of the National By-Laws and the Manual of Procedure covering the nomination, election and installation of Post Officers. Post Election Reports must be submitted online through OMS by the Post Quartermaster.
- **8. ELECTION REPORT FILING:** All current Post Quartermasters must submit the 2023-2024 Election Report online through the OMS system.
- 9. DEPARTMENT'S WEBSITE MEMBERS ONLY SECTION: Go to www.vfwdeptla.org, on the right side click the Login Tab, click Members Only. The username will be the VFW Members Membership Number and the password will be the VFW Members last name.
- 10. DISTRICT CONVENTION: Pursuant to Section 403 of the National By-Laws and the Manual of Procedure, each District shall hold an annual District convention for the purpose of electing District officers, such convention to be held not less than ten (10) days nor more than seventy-five (75) days prior to the convening of the Department convention. District may have the district meeting declared null and void if not held in this time frame in accordance with Section 403 of Manual of Procedure. Special note: Section 403 – Inpart States: Regular meeting -- unless otherwise provided for in Dept ByLaws, District shall hold at least three (3) regular meetings each year for purposes as prescribed in the Manual of Procedure and one of which must be a school of instructions/workshop. All Districts holding only two meetings a year are hereby informed and instructed to hold three (3) meeting a year in accordance with VFW ByLaws and Manual of Procedure.

GENERAL ORDERS CONTINUED

- **11. ARREARAGE LETTERS**: Arrearage letters were mailed to the Post Commander in the month of April along with the Credential Cards for Delegates and Alternates to the State Convention.
- 12. DELEGATES AND ALTERNATES: To the Department Convention shall be elected at a regular meeting of the Post held not less than thirty (30) days prior to the Department Convention; one (1) delegate and one (1) alternate for each thirty (30) members or fraction thereof in good standing in the Post at the time of the election or as the Department ByLaws may provide.
- 13. COMMUNITY SERVICE: ALL POSTS ARE REQUIRED TO SUBMIT AT LEAST ONE REPORT IN EACH OF THE DIFFERENT PROGRAMS THAT THE VFW participates in, such as Community Service, Hospital Program, POW/MIA Program, Americanism Programs, Loyalty Day Programs, Safety Programs, Youth Activities, Voice of Democracy, Patriots Pen, & Teachers ETC. Reports are to be submitted on the Department's Website under the Member's Only Section. If you have any questions, contact the State Community Service Chairman, James Prestenback (Email: jprestenback302@gmail.com)
- 14. MEMBERSHIP APPLICATIONS: The attention of Department, District, and Post Commanders is directed to Section 103, Manual of Procedure, which prescribes the way application for membership will be handled. Applications for membership of new, reinstated or Transfer Members are voted on by the members present at a regular Post Meeting

- 15. ALL AMERICAN DASHBOARD NOW KNOWN AS THE "PROGRAM DASHBOARD": Post Adjutants should have access to the National Program Dashboard by logging in at www.vfw.org. Post are encouraged to be sure the correct Adjutant is listed on their Post Election Report. Post Adjutants should receive all Program Information from Chairman within the Post. This information should be entered the Program Dashboard for National. Once the Post Adjutant enters this information, it must be approved by the District Adjutant.
- **16. VOTING STRENGTH:** To calculate the Post Voting Strength, take the current year total as of March 31st and divide it by 30. Example: Current Total as of March 31st is 35. 35 divided by 30 is 1.1666. So Post would get to Delegate Votes + 1 Commander Vote. Therefor, the voting strength would be 2 + 1.
