


STATE COMMANDER MESSAGE

MANDATORY:

General Orders: All material in the State General Orders is directive in nature and will be read to the membership at the Post regular membership meetings each month. **Some of these have remained the same** and will remain for a while longer to instill their importance to our order. New Items will be added to the General Order and will have some highlighted in Red areas.

- 1. Attention of Post Commanders is directed to Section 222 of the National Bylaws and the Manual of Procedure, which provides that each Post will pay, in advance, a National Convention registration fee of twenty-five dollars (\$25) which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Each additional delegate attending the National Convention will pay a ten dollar (\$10) delegate fee. Posts are encouraged to register their Post delegate(s) online through the Online Membership System (OMS) or by submitting their National Convention Post and Delegate Registration form that will be mailed to all Posts as part of the Election Report/Convention Registration mailing going out later this month. Registration forms for the 124th National Convention may be mailed to: Convention Registration, 406 W. 34th Street, Kansas City, MO 64111.
- 2. Attention is directed to Section 217 of the National Bylaws and the Manual of Procedure covering the nomination, election and installation of Post Officers. Post Election Report forms are being mailed to Post Quartermasters with instructions that they complete the form online through the Online Membership System (OMS) or they can complete the form and return directly to National Headquarters immediately following the election of Post Officers but not later than June 1.
- 3. Section 222 of the National Bylaws and the Manual of Procedure provides that delegates and alternates for the District Convention and meetings, Department and National Conventions shall be elected at a regular meeting in April. Posts are entitled to one (1) delegate and one (1) alternate for each thirty (30) members or fraction thereof in good standing in the Post as of March 31.
- 4. Pursuant to Section 403 of the National Bylaws and the Manual of Procedure, each District shall hold an annual District Convention for the purpose of electing District officers, such convention to be held not less than ten (10) days nor more than seventy-five (75) days prior to the convening of the Department Convention. Pursuant to Section 403 of the National Bylaws Regular Meeting, Districts shall hold at least two (2) regular meetings each year for purposes of transacting business and conducting schools of instruction.

Pursuant to Section 417 of the National Manual of Procedure, District officers shall not assume the duties of their office until the Department Commander is installed.

District officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed in accordance with Section 416 of the Manual of Procedure.

5. Attention of Post Commanders is directed to Section 218 (a)(11) of the National Manual of Procedure, wOfficers: Duties and Obligations. Trustees Report of Audit must be prepared in detail within thirty (30) days from the end of each quarter, one of which ends March 31.

STATE SR. VICE COMMANDER'S MESSAGE





Legislative Report January 2024

These are the key Topics from this month. Please read through these and let me know your thoughts on how we can continue to show Louisiana, that our Elected Officials are committed to our Veterans.

January 8th:

VFW 2024 Priority Goals: The 118th Congress is now in its second session, and there is still work to be done. The VFW 2024 Priority Goals include many issues concerning benefits and services for veterans, service members, and their families. FY 2024 NDAA Signed into Law: On Dec. 22, 2023, President Biden signed the National Defense Authorization Act (NDAA) for Fiscal Year 2024 into law. This legislation focuses on DOD priorities and expenditures. It also authorizes appropriations but does not provide budget authority, which is provided by appropriations legislation. Read more.

Camp Lejeune Justice Act Informational Update:

Veterans and family members seeking to file lawsuits because of water contamination at Camp Lejeune have only months left to do so. The VFW has partnered with trusted law firms to help those seeking to file suit against the government. BMBF Law and Bergman & Moore are here to help affected individuals. Section 804 of the PACT Act (P.L. 117-168), the Camp Lejeune Justice Act of 2022, allows that individuals may qualify if they resided, worked, or were otherwise exposed (including in utero) to the ground water at Camp Lejeune for not less than 30 days during the period from Aug. 1, 1953, to Dec. 31,1987; and have been diagnosed with a cancer, serious illness, or numerous other health conditions including neurological, kidney and liver diseases, miscarriages, infertility, and birth defects/cognitive disabilities in children. Your condition does not have to be on the VA presumptive list or the Centers for Disease Control and Prevention Agency for Tox-

ic Substances and Disease Registry to file a claim. Surviving family members may pursue claims on behalf of deceased loved ones.

January 15th:

VFW Attends SVA NatCon 2024: VFW members were recognized for their outstanding commitment to the student veteran community during Student Veterans of America's (SVA) 16th Annual National Conference (NatCon), held this year in Nashville, Tennessee. Denny Cosmo of Bristol Community College received the SVA Chapter Advisor of the Year Award. Eric D'Arce, of Suffolk County Community College, was named as a Student Veteran of the Year finalist. D'Arce also serves as VFW Post 291 3's Jr. Vice Commander and District 11 Legislative Chairman. Additionally, VFW-SVA Legislative Fellow Jamie Springston was selected as a finalist for Student Veteran of the Year. During the conference, VFW-accredited service officers assisted hundreds of student veterans at a claims clinic on site. VFW Washington Office Executive Director Ryan Gallucci addressed the conference's general session stating, "Service organizations like SVA and VFW are vital to veterans to thrive through transition and beyond."

VFW National Home: The National Home was founded in 1925 as a place where the families left behind by war could remain together. Today's families face different challenges, and the National Home has evolved over decades to meet those needs. The community is open to the families of active-duty military personnel, veterans, and relatives of VFW and VFW Auxiliary members. Families may consist of one or both parents with one or more children. If your family needs help, please contact the helpline by calling 800.313.4200.

January 22nd:

House Investigation on VA Revolving Funds: The House Subcommittee on Oversight and Investigations held a hearing on VA's handling of revolving funds. A revolving fund is a business run by a federal agency, under authority granted by Congress, comprised of enterprises that provide services and collect fees. VA publishes the Franchise Fund's annual report, but the Supply Fund's financial statements are not public. It was discovered that the Supply Fund ran a \$37 million loss last year, but the financial statements characterized it as a profit. "I hope you can see why I am concerned," said Chairwoman Jen Kiggans. "This is not transparency." Watch the hearing, which begins at the 32:23 mark.

Mental Health Care Services During

Transition: The Military Health System's inTransition program aids service members, veterans, and retirees — regardless of component, time served, or discharge category — to establish or transfer mental health care during times of transition. This program is a free service that is not time limited. It is staffed with qualified coaches familiar with military culture who stand ready to assist individuals to connect with the care they need. Read more.

January 29th:


Volunteer to Vet the Vote: Tuesday, Jan. 30, is Help America Vote Day. This event provides an opportunity for veterans and military family members to volunteer as poll workers for Election Day 2024. The removal of \$1.1 million to update the Memorial Benefits Management System for the NCA will no doubt create a setback in the progress VA anticipated relating to the allocation of funds. The VFW's 2024 Priority Goals include an increase in burial allowances to account for inflation. Proper funding to facilitate benefits management for eligible veterans is a crucial step in meeting this key objective. Read more.

VFW 2024 Priority Goals: The 118th Congress is now in its second session, and there is still work to be done. The VFW 2024 Priority Goals include many issues concerning benefits and services for veterans, service members, and their families. - Use handrails when walking on stairs.
- Use well-lit pathways or carry a flashlight for use in dark places.
- Wear comfortable, slip-resistant shoes.
- Use a cart and take the elevator when carrying bulky items.
- Stay focused and alert.
- Put your cell phone away when you are on the move.
- Use walkways and pedestrian paths.
- Wipe your feet on a mat when entering a building during wet weather.
- Know your ability, be willing to ask for assistance if in doubt.

This time around it was cooler weather, but warmer weather is coming. At our next gathering in June, the sun will be shining, and it will be hot. Please remember to maintain hydration and understand the symptoms of heat exhaustion and heat stroke.

Preventing Heat Illness

Avoid the heat

When indoors...

- Use electric fans or air conditioners to adjust the temperature
- Use shading curtains, bamboo screens, and sprinkle water
- Check your room temperature regularly
- ▶ Refer to the WBGT value*

When outdoors...

- Use a parasol and wear a hat
- Stay in the shade and take a break regularly
- On sunny days, try to avoid going outdoors in daytime

To prevent your body from accumulating heat

- Wear clothes that breathe well, absorb moisture, and dry quickly
- Use ice packs, ice, cold towels, etc. to cool your body

*WBGT value: An index calculated based on the temperature, humidity, and radiant heat Reference values are provided according to the level of exercise or work.

Observed values and predicted values are indicated on the Ministry of the Environment's website (Heat Illness Prevention Information website).

Stay hydrated

When indoors or outdoors, regularly intake water and salt or drink an oral rehydration solution* even when you do not feel thirsty

*Water with salt and glucose dissolved into it

"Heat illness" refers to a state where the balance of water and salt in a person's body is gradually broken, thermoregulation fails to function properly, and heat is accumulated in the body, due to being in a high-temperature and high-humidity environment for a long time. It can occur not only when you are outdoors, but also when staying indoors not doing any exercise or work. Heat illness victims may be taken to hospital by ambulance and in some cases die from it.

In order to prevent health problems caused by heat illness, each individual should have a correct understanding of heat illnesses, be aware of changes in their physical condition, and look out for those around them.

Heat illness symptoms

- ODizziness, giddiness, numbness in limbs, muscle cramp, feeling unwell
- OHeadache, nausea, vomiting, dullness, despondency, different from usual In serious cases:
 - Response is not normal, unconsciousness, convulsion, body is hot

If you come across people suspected of heat illness

Take them to a cool place

Take them to a cool place such as an air-conditioned room or shady spot with good ventilation

Cool their body

Loosen their clothes and cool their body (Especially around the neck, under the armpits, groins, etc.)



Hydration

Give them water, salt, oral rehydration solution*, etc.

*Water with salt and glucose dissolved into it

If they are unable to drink themselves or unconscious, call an ambulance right away!

<Reminders>

People feel heat in different ways

The way people feel heat depends on their physical condition on that day, whether they are used to heat, and other factors. Be mindful of changes in your physical condition.

Elderly people, children, and those with disabilities need to be especially kept an eye on

- Half of heat illness patients are elderly people aged 65 or above. Caution is necessary since elderly people are less able to
- Children need to be kept an eye on since their body temperature adjustment functions are not fully developed yet.
- Hydrate yourself regularly even if you do not feel thirsty. Even if you do not feel hot, measure the room temperature and ambient temperature and try to adjust the temperature using electric fans and air conditioners.

Do not forget to take preventive measures against heat illness by being too conscious of saving power

On days when the temperature and humidity are high, do not try too hard to save power but use electric fans and air conditioners in moderation.

# Airman Accounted for from WWII (Colter, R.)

#### WASHINGTON -

The Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army Air Force Pvt. 1st Class Robert L. Colter, 23, of Lakeland, Florida, who was captured and died as a prisoner of war during World War II, was accounted for Sept. 25, 2023.

In late 1942, Colter was a member of 91st Bombardment Squadron, 27th Bombardment Group, in the Philippines during World War II, when Japanese forces invaded the Philippine Islands in December. Intense fighting continued until the surrender of the Bataan peninsula on April 9, 1942, and of Corregidor Island on May 6, 1942.

Thousands of U.S. and Filipino service members were captured and interned at POW camps. Colter was among those reported captured when U.S. forces in Bataan surrendered to the Japanese. They were subjected to the 65-mile Bataan Death March and then held at the Cabanatuan POW camp. More than 2,500 POWs perished in this camp during the war.

According to prison camp and other historical records, Colter died July 28, 1942, and was buried along with other deceased prisoners in the local Cabanatuan Camp Cemetery in Common Grave 215.

Following the war, American Graves Registration Service (AGRS) personnel exhumed those buried at the Cabanatuan cemetery and relocated the remains to a temporary U.S. military mausoleum near Manila. In 1947, the AGRS examined the remains in an attempt to identify them. Five sets of remains from Common Grave 215 were identified, but the rest were declared unidentifiable. The unidentified remains were buried at the Manila American Cemetery and Memorial (MACM) as Unknowns.

In early 2018, the remains associated with Common Grave 215 were disinterred and sent to the DPAA laboratory for analysis.

To identify Colter's remains, scientists from DPAA used anthropological analysis, as well as circumstantial evidence. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) analysis.

Although interred as an Unknown in MACM, Colter's grave was meticulously cared for over the past 70 years by the American Battle Monuments Commission (ABMC).

Colter will be buried in a place and time to be determined by the family.

# Airman Accounted for from WWII (Stevens, H.)

WASHINGTON -

The Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army Air Forces Staff Sgt. Henry L. Stevens, 23, of Monroe, Louisiana, killed during World War II, was accounted for Sept 15, 2023.

In late 1944, Stevens was assigned to the 557th Bombardment Squadron, 387th Bombardment Group, Ninth U.S. Air Force, in the European Theater of Operations. On Dec. 23, Stevens was a crewmember aboard a B-26F "Marauder" aircraft, nicknamed *Shirley D*, which was shot by anti-aircraft fire over Bitburg, Germany, while returning from a bombing raid. Witness reported *Shirley D* took damage to the right engine, resulting in a massive fire which forced crewmen to bail out. Survivors watched *Shirley D* crash near Winville, Belgium, with several crewmembers, including Stevens, still onboard.

A few days after the crash, several Belgian residents recovered one set of remains from the crash site near Houmont and turned them over to American forces operating in the area. American Graves Registration Service (AGRS) personnel initially identified the pilot, while the other set of remains remained Unknown. By Dec. 26, 1944, everyone from Stevens's aircraft had been identified and accounted for except for Stevens, and he was declared non-recoverable.

In 2013, DPAA personnel returned to the crash site near Winville, Belgium, where they recovered materials associated with the crashed B-26. Later in 2019, while working in conjunction with researchers from the University of Wisconsin, possible remains were located and sent to the DPAA laboratory for testing and possible identification.

To identify Stevens's remains, scientists from DPAA used anthropological analysis. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) and autosomal DNA (auSTR) analysis.

Stevens's name is recorded on the Tablets of the Missing at the Ardennes American Cemetery, an American Battle Monuments Commission site in Neupré, Belgium, along with others still missing from WWII. A rosette will be placed next to his name to indicate he has been accounted for.

Stevens will be buried on March 8, 2024, in Bushnell, Florida.

Thousands of U.S. and Filipino service members were captured and interned at POW camps. Seibert was among those reported captured when U.S. forces in Bataan surrendered to the Japanese. They were subjected to the 65-mile Bataan Death Seibert and then held at the Cabanatuan POW Camp #1. More than 2,500 POWs perished in this camp during the war.

According to prison camp and other historical records, Seibert died July 27, 1942, and was buried along with other deceased prisoners in the local Cabanatuan Camp Cemetery in Common Grave 225.

Following the war, American Graves Registration Service (AGRS) personnel exhumed those buried at the Cabanatuan cemetery and relocated the remains to a temporary U.S. military mausoleum near Manila. In 1947, the AGRS examined the remains in an attempt to identify them. Three of the sets of remains from Common Grave 225 were identified, but the rest were declared unidentifiable. The unidentified remains were buried at the Manila American Cemetery and Memorial (MACM) as Unknowns.

In Seibert 2018, the remains associated with Common Grave 225 were disinterred and sent to the DPAA laboratory for analysis.

To identify Seibert's remains, scientists from DPAA used anthropological analysis as well as circumstantial evidence. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA), Y-chromosome DNA (Y-STR) and autosomal DNA (auSTR) analysis.

Although interred as an Unknown in MACM, Seibert's grave was meticulously cared for over the past 70 years by the American Battle Monuments Commission (ABMC).

Seibert will be buried on a date and location to be determined by the family.

# Thomas Crayton Master Sergeant, U.S. Army

## Soldier Accounted for from Korean War (Crayton, T.)

Washington D.C. -

The Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army Master Sgt. Thomas Crayton, 28, of Austin, Texas, killed during the Korean War, was accounted for Sep. 26, 2023.

In Nov. 1950, Crayton was a member of Alpha Battery, 503rd Field Artillery Battalion, 2nd Infantry Division, Eighth U.S. Army. He went missing in action and captured by enemy forces after his unit engaged combat actions in the vicinity of Somindong, North Korea, on Dec. 1, 1950. Shortly after he went missing, Chinese forces announced MSG Crayton had been captured as a Prisoner of War. In 1953, several POWs returned during Operation Big Switch reported Crayton had been a prisoner of war and died on Feb. 11, 1951, at Prisoner of War Camp #5. His remains were not immediately recovered or identified after the war.

In 1954, during Operation Glory, North Korea unilaterally turned over remains to the United States, including one set, designated Unknown X-14240. The remains were reportedly recovered from prisoner of war camps, United Nations cemeteries and isolated burial sites. None of the remains could be identified as Crayton and he was declared non-recoverable on Aug. 24, 1953. The remains were subsequently buried as an unknown in the National Memorial Cemetery of the Pacific in Honolulu.

Chinese prison camp administrators moved many of their prisoners between POW Camps 1 and 5, and historical records and contemporary analysis have shown that the Chinese and North Korean recovery data has frequently proven inaccurate. In February 2020, scientists from the DPAA laboratory disinterred Unknown X-14240 from the NMCP for scientific analysis.

To identify Crayton's remains, scientists from DPAA used dental and anthropological analysis, as well as chest radiograph and other circumstantial evidence. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) analysis.

Crayton's name is recorded on the Courts of the Missing at the Punchbowl, along with the others who are still missing from the Korean War. A rosette will be placed next to his name to indicate he has been accounted for.

Crayton will be buried in Austin, Texas, on a date to be determined.





# Leroy C. Cloud Staff Sergeant, US Army

## Tanker Accounted for from WWII (Cloud, L.)

Washington D.C. -

The Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army Staff Sgt. Leroy C. Cloud, 24, of Thrall, Texas, killed during World War II, was accounted for Aug 29, 2023.

In July 1944, Cloud was assigned to Company A, 744th Tank Battalion, as a crew member of an M5A1 Stuart light tank. His unit was engaged in battle with German forces at Saint-Germain-d'Elle, France, on July 26 when his tank was struck by an enemy shoulder-fired rocket. Two crewmembers were able to escape the vehicle, but Cloud and another Soldier were never seen or heard from again. Due to strong enemy artillery fire and intense combat, surviving crewmembers were unable to recover Cloud's remains. He was declared missing in action, but the Germans never reported him as a prisoner of war. On Aug 16, with no evidence Cloud survived the fighting, the War Department issued a report of death.

Following the end of the war, the American Graves Registration Command (AGRC) was tasked with investigating and recovering missing American personnel in Europe. On July 30, 1944, AGRC personnel recovered two sets of remains from an M5A1 destroyed in the vicinity of Saint-Lô. Ultimately, they could not identify the remains, designated X-141 and X-142 St. Laurent, and they were interred in the Normandy American Cemetery, France.

While studying unresolved American losses in the Saint-Germain-d'Elle area, a DPAA historian determined that the M5A1 Stuart tank recovered from the area belonged to Company A, where Cloud was assigned. This correlation led DPAA and American Battle Monuments Commission (ABMC) personnel to exhume the remains of X-141 and X-142 in April 2018 and sent to the DPAA laboratory for analysis and identification.

To identify Cloud's remains, scientists from DPAA used dental and anthropological analysis, as well as circumstantial evidence. Additionally, scientists from the Armed Forces Medical Examiner System used Y chromosome DNA (Y-STR) analysis.

Cloud's name is recorded on the Walls of the Missing at Normandy American Cemetery, an American Battle Monuments Commission site in Colleville-sur-Mer, France, along with the others still missing from World War II. A rosette will be placed next to his name to indicate he has been accounted for.

Cloud will be buried in Taylor, Texas, on April 7, 2024.





# Merle C. J. Hillman

Pharmacist's Mate 2nd Class, U. S. Navy (Massachusetts)

# Sailor Accounted for from USS California (Hillman, M.)

Washington D.C. -

The Defense POW/MIA Accounting Agency (DPAA) announced today that Pharmacist's Mate 2nd Class (PhM2c) Merle C. J. Hillman, 25, of Holyoke, Massachusetts, killed during World War II, was accounted for on October 20, 2023.

On Dec. 7, 1941, Hillman was assigned to the battleship USS *California*, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft. The USS *California* sustained multiple torpedo and bomb hits, which caused it catch fire and slowly flood. The attack on the ship resulted in the deaths of 104 crewmen, including Hillman.

From December 1941 to April 1942, Navy personnel recovered the remains of the deceased crew, which were subsequently interred in the Halawa and Nu'uanu Cemeteries.

In September 1947, tasked with recovering and identifying fallen U.S. personnel in the Pacific Theater, members of the American Graves Registration Service (AGRS) disinterred the remains of U.S. casualties from the two cemeteries and transferred them to the Central Identification Laboratory at Schofield Barracks. In addition to the 42 casualties from the USS *California* initially identified after the attack, the laboratory staff was only able to confirm the identifications of 39 men from the USS *California* at that time. The AGRS subsequently buried the unidentified remains at the National Memorial Cemetery of the Pacific (NMCP), known as the Punchbowl, in Honolulu. In October 1949, a military board classified the remains of the unresolved crew members, including Hillman, as non-recoverable.

In 2018, DPAA personnel exhumed the 25 USS *California* Unknowns from the Punchbowl for analysis.

To identify Hillman's remains, scientists from DPAA used anthropological analysis. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA), and Y chromosome DNA (Y-STR) analysis.

Hillman's name is recorded on the Walls of the Missing at the Punchbowl, along with the others who are missing from WWII. A rosette will be placed next to his name to indicate he has been accounted for.

Hillman will be buried on Jan. 27, 2024, in Holyoke, Massachusetts.

# Roy E. Barrow Master Sergeant, U.S. Army

### Soldier Accounted for from Korean War (Barrow, R.)

The Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army Master Sgt. Roy E. Barrow, 39 of Valdosta, Georgia, killed during the Korean War, was accounted for Sept. 22, 2023.

At the end of World War II, the U.S. military began a lengthy process of downsizing it forces. Many troops, especially commissioned officers, felt the call to continue service of their nation. As such, Lieutenants and Captains would be offered a reduction to Master Sergeant. This was the case with MSG Barrow, who had been reduced in rank when called to serve in the Korean War.

In the winter of 1950, MSG Barrow was a member of King Company, 3rd Battalion, 31st Infantry Regiment, 7th Infantry Division. He was reported missing in action on Dec. 12 after his unit was attacked by enemy forces as they attempted to withdraw near the Chosin Reservoir, North Korea.

In 1954, during Operation Glory, North Korea unilaterally turned over remains to the United States, including one set, designated Unknown X-15869 Operation Glory. The remains were reportedly recovered from prisoner of war camps, United Nations cemeteries and isolated burial sites. None of the remains could be identified as Barrow and he was declared nonrecoverable on Jan. 16, 1956. The remains were subsequently buried as an unknown in the National Memorial Cemetery of the Pacific in Honolulu.

In 2013, DPAA disinterred X-15869, and after a decade of scientific advances and increased historical research, DPAA was able to positively associate X-15869 to Barrow.

To identify Barrow's remains, scientists from DPAA used chest radiograph comparison, dental and anthropological analysis. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) analysis.

MSG Barrow's name is recorded on the Courts of the Missing at the Punchbowl, along with the others who are still missing from the Korean War. A rosette will be placed next to his name to indicate he has been accounted for.

MSG Barrow will be buried in Valdosta, Georgia, on January 27, 2024.

# Pilot Accounted for from WWII (Willhite, T.)

The Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army Air Forces Major Theodore Willhite, 26, of Muscatine, Iowa, killed during World War II, was accounted for Sept. 19, 2023.

In March of 1944, Willhite was assigned to the 724th Bombardment Squadron, 451st Bombardment Group, 15th Air Force in the Mediterranean and European Theater of Operations. On Mar 11, Willhite was piloting a B-24 "Liberator," when it was struck by anti-aircraft fire after a bombing raid on a German position near Toulon, France. Eyewitnesses on another B-24 reported seeing Willhite's aircraft spinning out of control at approximately 3000 feet before breaking apart and crashing into the sea. All 11 crewmembers aboard the aircraft were lost in the incident and not identified following the war.

Beginning in 1945, the American Graves Registration Command (AGRC), Army Quartermaster Corps, was the organization tasked with recovering missing American personnel in the European Theater. Following the war, the AGRC disinterred and identified seven sets of remains recovered from the Lagoubran Cemetery, at Toulon, France. At the time they were unable to identify Willhite and other crewmembers, and they were interred in the Rhône American Cemetery.

In 2019, DPAA investigators and American Battle Monuments Commission personnel exhumed the remains of X-84 Luynes, X-85 Luynes, X-86 Luynes, and X-92 Luynes and sent them to the DPAA laboratory for analysis and identification.

To identify Willhite's remains, scientists from DPAA used anthropological analysis. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) analysis.

Willhite's name is memorialized on the Walls of the Missing at Rhône American Cemetery, an American Battle Monuments Commission site in Draguignan, France, along with others still missing from WWII. A rosette will be placed next to his name to indicate he has been accounted for.

Willhite will be buried at a place and time to be determined by the family.





## Herbert F. March

# Airman Accounted for from WWII (March, H.)

The Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army Air Forces Technician 4th Grade (TECH4) Herbert F. March, 24, of Cook, Washington, who was captured and died as a prisoner of war during World War II, was accounted for Aug. 10, 2023.

In late 1941, March was a member of Headquarters Squadron, 24th Pursuit Group, when Japanese forces invaded the Philippine Islands in December. Intense fighting continued until the surrender of the Bataan peninsula on April 9, 1942, and of Corregidor Island on May 6, 1942.

Thousands of U.S. and Filipino service members were captured and interned at POW camps. March was among those reported captured when U.S. forces in Bataan surrendered to the Japanese. They were subjected to the 65-mile Bataan Death March and then held at the Cabanatuan POW Camp #1. More than 2,500 POWs perished in this camp during the war.

According to prison camp and other historical records, March died July 26, 1942, and was buried along with other deceased prisoners in the local Cabanatuan Camp Cemetery in Common Grave 225.

Following the war, American Graves Registration Service (AGRS) personnel exhumed those buried at the Cabanatuan cemetery and relocated the remains to a temporary U.S. military mausoleum near Manila. In 1947, the AGRS examined the remains in an attempt to identify them. Three of the sets of remains from Common Grave 225 were identified, but the rest were declared unidentifiable. The unidentified remains were buried at the Manila American Cemetery and Memorial (MACM) as Unknowns.

In March 2018, the remains associated with Common Grave 225 were disinterred and sent to the DPAA laboratory for analysis.

To identify March's remains, scientists from DPAA used anthropological analysis as well as circumstantial evidence. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) and Y-chromosome DNA (Y-STR) analysis.

Although interred as an Unknown in MACM, March's grave was meticulously cared for over the past 70 years by the American Battle Monuments Commission (ABMC).

March will be buried in Woodland, Washington, on a date to be determined.

If a Post does not use a credit card, the Post will send their donation to their Department HQs and the Department HQs will submit the donation for their Post. Credit will automatically update on the Dashboard daily.

Overseas Departments will donate for the other programs through the link also in lieu of participation. This will automatically update daily.

Your \$100 or more donation meets the eligibility criteria for All-American in this category.

**DISPLAYING MILITARY SERVICE SYMBOLS.** Military service flags, insignias, etc. should be displayed in the following order (left to right as you face the flags): Army, Marine Corps, Navy, Air Force, Space Force and then Coast Guard. PROGRAMS DASHBOARD TOOL. (NOTE: Previously ALL-AMERICAN DASHBOARD) Please encourage Posts to read the 2023-24 Membership program. Military Assistance Program grants have been launched to show Departments and Posts how much in grant assistance has been received from National HQs to supplement the Unmet Needs financial grants & VFW Sport Clips Help A Hero scholarship statistics. The information charts reside in the KPI tools section.

**SMART/MAHER VFW NATIONAL CITIZENSHIP EDUCATION TEACHER AWARD PROGRAM REMINDER.** Nominations for this award and the judging at the Post, District and Department level (if applicable) should be completed. After Department judging, each Department could have selected one candidate from each category and submitted their winners to VFW National Headquarters by Feb. 1. The Department Teacher winners that are received at National Headquarters will be entered in the National judging and receive a VFW National citation for both the winning teacher and their school.

NOTE: The only item the National VFW Programs Department requires is the "VFW Department Teacher Award Citation Request Form" with the entry documentation downloaded. A link has been forwarded to the Department Adjutant/Quartermaster to submit it to National Headquarters by Feb. 1. **VOICE OF DEMOCRACY AND PATRIOT'S PEN NATIONAL AWARDS.** Every Voice of Democracy and Patriot's Pen first place Department winner will receive a National scholarship or award. The amount for the Voice of Democracy National Awards now totals \$172,000, with the top three awards being raised to \$35,000, \$21,000 and \$15,000. The Patriot's Pen National Awards total is \$55,000.

**NEW UPDATES.** VFW National Programs has updated the Fred C. Hall and Outstanding Community Service Post award programs starting this program year. Please share this with your Community Service Chairpersons.

#### The new programs are as follows:

FRED C. HALL MEMORIAL AWARD FOR COMMUNITY SERVICE. Each year on July 1, the national Programs office will determine the top community service Posts in each conference, based off their community service reporting and total impact, from July 1 to June 30 the previous year. Your community service total impact is figured by the money spent to host and organize the community service event, plus total hours all

volunteers participated, plus the mileage for all volunteers (Dollars Donated + Hours + Mileage = Total Impact).

These four Posts will be awarded the Fred C. Hall Memorial Award for Community Service and will be invited to attend the VFW National Convention. The Post Commander (or designated representative) and a guest will receive round-trip airfare, hotel accommodations for five nights, and a \$599 stipend to receive the award at the VFW National Convention.

OUTSTANDING COMMUNITY SERVICE POST OF THE YEAR. Each Department will have an OCSP winner based on total impact also. National will select based on end of year reports on July 1. Winners will also be published in the Convention program booklet and receive a street sign identifying this national award for the Post to put up in their community.

"UPDATED" POW/MIA FLAG -- OFFICIAL DISPLAY DAYS. Under previous Public Law 105-85 (Nov. 16, 1997), it indicated there were only six days that federal agencies, military installations and U.S. post offices were required to display the POW/MIA flag. Now under new law, Public Law 116-67 (Feb. 21, 2020), it is required that the POW/MIA flag be flown on all days on which the flag of the United States is displayed. IRS AND VFW AWARD MONIES. The Internal Revenue Service (IRS) requires that any recipient that receives more than a \$599 award should receive a Form 1099 identifying the proceeds as taxable. This will include the VFW programs Patriot's Pen and Smart/Maher VFW National Citizenship Education Teacher Award.

### "Buddy"® Poppy

"BUDDY" POPPY CAMPAIGN. Although we emphasize Buddy Poppies on Veterans Day and Memorial Day, it is important to realize that the distribution of Buddy Poppies should be a year-round exercise. Each time a Post participates in an activity where the public will be present, Buddy Poppies should be present as a fundraising tool and simply to recognize our fallen comrades.

Where the VFW appears, Buddy Poppies should be a constant reminder that we will never forget those who have perished in the name of liberty. Just as "They Gave, Will You?" is a year-round thing, so should the distribution of VFW Buddy Poppies.

Remember that your poppies should be ordered a minimum of three (3) weeks in advance of your distribution date.

BUDDY POPPY UPDATE: National Headquarters conducted a review of the Buddy Poppy policy and procedures and implemented the following changes effective Jan. 1, 2024:

- 1) Departments must order poppies through OMS.
- 2) All claims of non-receipt of a Buddy Poppy order must be made within 90 days of the date of the order or will NOT be replaced free of charge.
- 3) All orders for the traditional Buddy Poppy, Anniversary Poppies or tin tab poppies must be placed through your Department Headquarters. Auxiliaries must go through their Post to order all poppies.
- 4) The tabs do count towards the Buddy Poppy requirement for the All-American program.
- 5) If you do not receive your order within four weeks of placing it with your Department, please contact your Department Headquarters to report you have not received your order.
- 6) All poppies are shipped within 10 days of ordering except orders placed in June and July, due to preparation for National Convention, please allow an additional five business days.

Miscellaneous items (coin cans, buttons, posters, etc.) should be ordered directly from the VFW Store at vfwstore.org/category/programs/buddypoppy, or the VFW Store/Emblem and Supply Catalog.

The Manual of Procedure provides that Post relief funds may be used for programs such as Voice of Democracy, Patriot's Pen, Citizenship Education, and Community Service as long as suggestions in the chairperson's guidebooks are used as an example of promoting these programs.

Posts are further reminded that Section 711 of the Manual of Procedure provides that non-profit organizations, exempt from taxes under Section 501(a) of the Internal Revenue Code, may assist with the distribution of Buddy Poppies, provided there shall be no division of proceeds. A donation to these groups may be made from the Post general fund.

VFW SILVER, GOLD AND DIAMOND ANNIVERSARY POPPIES. The silver, gold and diamond anniversary Buddy Poppies are for Posts that are currently in their 25th, 50th or 75th anniversary years. For Posts currently in their 100th year anniversary, they can order any color and as many as they need.

Please limit your order of anniversary poppies to 1,000 to ensure stock does not run out unless you are currently in your 100th year. These are ordered through the Department in OMS and processed the same as the red poppies. Currently we have no plans to replenish inventory due to increased cost and the small quantities we sell of the Anniversary Poppies. Based on the past four years' sales, we have sufficient inventory for the next 3.5 years of the Gold, 5 years of Diamond and 52 years of the Silver.

### CAMP LEJEUNE LEGAL CLAIMS


