## STATE COMMANDER MESSAGE


Greetings Comrades,

#### **MANDATORY:**

**General Orders**: All material in the State General Orders is directive in nature and will be read to the membership at the Post regular membership meetings each month. **Some of these have remained the same** and will remain for a while longer to instill their importance to our order. New Items will be added to the General Order and will have some highlighted in Red areas.

- 1. Attention of Post Commanders is directed to Section 222 of the National Bylaws and the Manual of Procedure, which provides that each Post will pay, in advance, a National Convention registration fee of twenty-five dollars (\$25) which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Each additional delegate attending the National Convention will pay a ten dollar (\$10) delegate fee. Posts are encouraged to register their Post delegate(s) online through the Online Membership System (OMS) or by submitting their National Convention Post and Delegate Registration form that will be mailed to all Posts as part of the Election Report/Convention Registration mailing going out later this month. Registration forms for the 124th National Convention may be mailed to: Convention Registration, 406 W. 34th Street, Kansas City, MO 64111.
- 2. Attention is directed to Section 217 of the National Bylaws and the Manual of Procedure covering the nomination, election and installation of Post Officers. Post Election Report forms are being mailed to Post Quartermasters with instructions that they complete the form online through the Online Membership System (OMS) or they can complete the form and return directly to National Headquarters immediately following the election of Post Officers but not later than June 1.
- 3. Section 222 of the National Bylaws and the Manual of Procedure provides that delegates and alternates for the District Convention and meetings, Department and National Conventions shall be elected at a regular meeting in April. Posts are entitled to one (1) delegate and one (1) alternate for each thirty (30) members or fraction thereof in good standing in the Post as of March 31.
- 4. Pursuant to Section 403 of the National Bylaws and the Manual of Procedure, each District shall hold an annual District Convention for the purpose of electing District officers, such convention to be held not less than ten (10) days nor more than seventy-five (75) days prior to the convening of the Department Convention. Pursuant to Section 403 of the National Bylaws Regular Meeting, Districts shall hold at least two (2) regular meetings each year for purposes of transacting business and conducting schools of instruction. Pursuant to Section 417 of the National Manual of Procedure, District officers shall not assume the duties of their office until the Department Commander is installed.
- District officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed in accordance with Section 416 of the Manual of Procedure.
- 5. Attention of Post Commanders is directed to Section 218 (a)(11) of the National Manual of Procedure, Officers: Duties and Obligations. Trustees Report of Audit must be prepared in detail within thirty (30) days from the end of each quarter, one of which ends March 31.

During our Department Inspection in January, one change to our Department Bylaws was recommended by the National Inspection Team. That of moving one of our committees under the section with Standing Committees and taking it to of a section to itself. Doing a search in order to ensure everything else was up to date with our Bylaws.

I discovered in some areas we were out of compliance as far back as five **(5) years**. Our current Department Bylaws is dated June 20, 2021, and these are the three (3) changes that are vital to Posts, Districts, and our Department to become compliant with National's Bylaws.

Election and Appointed Officers; Chairman and Committees.

1. Taken from the 2019 Podium Edition, as amended July 25, 2018 and effective August 24, 2018. The following changes in Section 216, 416, and 516 were made concerning Officer election at the Post, District, and Department levels.

Sec. 216 - Elected and Appointed Officers; Chairmen and Committees.

- (a) The Post shall elect the Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster, and three Trustees. (Chaplain was removed as elected in the 2023 Podium Edition)
- (b) The Commander shall appoint an Adjutant, Chaplain, and Service Officer.
- (c) The Post may elect or the Post Commander may appoint a Judge Advocate, Surgeon, Officer of the Day and/or Guard if required by Post Bylaws.
- (d) The Post Commander may appoint such other chairmen and committees as deemed necessary to conduct the affairs of the Post or as may be required by Post Bylaws.

Sec. 416 - Elected and Appointed Officers; Chairmen and Committees.

- (a) The elected officers of each District shall consist of a Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster, and three (3)
- Trustees. (Chaplain was removed as elected in the 2024 Podium Edition and placed under (b) as a appointed officer)
- (b) The Commander shall appoint an Adjutant, Chaplain, and Service Officer and Inspector.
- (c) The District may elect or the District Commander may appoint a Judge Advocate, Surgeon, Chief of Staff or Officer of the Day if required by the District Bylaws.
- (d) The District Commander may appoint such other chairmen and committees as deemed necessary to conduct the affairs of the District or as may be required by District Bylaws.

Sec. 516 - Elected and Appointed Officers; Chairmen and Committees.

- (a) The elected officers of each Department shall be a Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster and Chaplain.
- (b) The Department Commander shall appoint an Adjutant, Inspector and Service Officer.
- (c) The Department may elect or the Department Commander may appoint a Judge Advocate, Surgeon, Chief of Staff or Officer of the Day if so required by Department Bylaws.
- (d) The Department Commander may appoint such chairmen and committees as deemed necessary to conduct the affairs of the Department or as may be required by Department Bylaws.
- (e) With respect to salaried officers, the appointment shall be made subject to confirmation of a majority vote of the Department Council of Administration.

This means if the Post, District, or Department Bylaws do not reflect that an Officer (i.e. Judge Advocate, Surgeon, and Chaplain at Post and District levels) is elected in their Bylaws, that position is appointed by the Post, District, or Department Commander's. The Chaplain at the Department level is still elected for now but the Department Bylaws must state that the Judge Advocate and Surgeon shall be elected at conventions or when vacant.

I realize every Post or District has or may not have a National approved Bylaws or any Bylaws at all as some do not. This brings me to the third discrepancy listed that I discovered and needs to be addressed and updated in our Department. But this second one concerns meetings.

Regular, Special, and Committee Meetings; Quorum; Authorized Attendees.

2. Taken from the 2022 Podium Edition, as amended August 3, 2021 and effective September 2, 2021. The following changes in Section 203, 403, and 503 were made concerning Bylaws at the Post, District, and Department levels.

Sec. 203 - Regular, Special and Committee Meetings; Quorum; Authorized Attendees. **Regular Meetings.** Posts shall hold at least one regular meeting each month. Failure to comply can result in immediate revocation of the Post Charter notwithstanding the provisions of Section 211 of the Manual of Procedure.

**Special Meetings.** Special meetings will be called in accordance with the procedures set forth in the Manual of Procedure.

**Committee Meetings**. Meetings called by Post Committee Chairmen, or as authorized by the Post Bylaws, for the purpose of conducting the business of that committee.

**Quorum**. The Post Bylaws may specify the minimum number of members required to constitute a quorum for the transaction of business at a regular or special meeting, provided that in no case shall the quorum be less than five (5) members. (Change removed physically present.)

**Electronic Attendance.** Any of the above stated meetings may be conducted or attended electronically that allows participating members to communicate with each other Simultaneously.

**Authorized Attendees.** Any member of the Post and those on official business shall be recognized by the Post Commander for the conduct of business.

**Guests.** With the approval of the Post Commander/Committee Chairman, any visiting member or guest may attend a Post/Committee meeting. Such visiting member or guest shall have no voice unless recognized by the Post Commander/Committee Chairman, and shall have no voting privileges.

Sec. 403 - Regular, Special and Committee Meetings; Convention; Quorum; Authorized Attendees.

**Regular Meeting.** Districts shall hold at least two (2) regular meetings each year for purposes of transacting business and conducting schools of instruction.

**Special Meeting.** Special meetings will be called in accordance with the procedures set forth in the Manual of Procedure. No business shall be transacted at any special meeting except that for which the meeting was called. Committee Meeting. Meetings called by District Committee Chairmen, or as authorized by the District Bylaws, for the purpose of conducting the business of that committee. Convention. Each District shall hold an annual District Convention for the purpose of electing District officers and for the transaction of business; such Convention to be held not less than ten (10) days nor more than seventy-five (75) days prior to the convening of the Department Convention.

Quorum. The minimum number of delegates required to constitute a quorum for the

transaction of business at District meetings and Conventions shall not be less than one (1) delegate each from fifty (50) percent of Posts in the District.

**Electronic Attendance.** Members may be allowed to participate in meetings using technology that allows participating members to communicate with each other simultaneously.

**Authorized Attendees.** Any member, not a member of the District Convention, may attend the Convention, however, they shall have no voice in business discussions unless requested by the Commander, and shall have no voting privileges. Those on official business shall be recognized by the Commander for the conduct of business.

Sec. 503 - Regular, Special and Committee Meetings; Convention; Quorum; Authorized Attendees.

Each Department shall hold one Convention each year, which shall begin no earlier than ninety days prior to the convening of the National Convention and shall be concluded no less than thirty (30) days prior to the conclusion of the National Convention. The minimum number of delegates required to constitute a quorum for the transaction of business at a Department Convention shall be not less than one delegate each from ten Posts in the Department unless the Department Bylaws may prescribe a different number of delegates required to constitute a quorum for the transaction of business. Any member in good standing or one on official business may visit a Department Convention; however, such visitor shall have no voice in business discussions unless recognized by the Commander, and shall have no voting privileges. Those on official business shall be recognized by the Commander for the conduct of business. The Department Council of Administration or Department Convention may allow delegates to participate in meetings using technology that allows participating members to communicate with each other simultaneously.

#### **Bylaws**

3. Taken from the 2023 Podium Edition, as amended July 19, 2022 and effective August 20, 2022. The following changes in Section 202, 402, and 502 were made concerning Bylaws at the Post, District, and Department levels.

Sec. 202 - Bylaws.

Posts shall, by a two-thirds (2/3) vote of the members present and voting at a regular or special meeting adopt Bylaws provided each member has been notified at least twenty (20) days in advance and, upon request has been provided a copy of the proposed Bylaws. Bylaws approved by a Post shall be forwarded as provided in the Manual of Procedure prior to becoming effective.

Amendments. Unless otherwise provided in the Post Bylaws, the Post Bylaws may be amended by a two-thirds (2/3) vote of the members present and voting at a regular or special meeting provided each member has been notified at least twenty (20) days in advance and, upon request has been provided a copy of the proposed amendments.

Sec. 402 - Bylaws.

The District Convention shall adopt or may amend Bylaws governing the District as prescribed in the Manual of Procedure, provided such Bylaws do not conflict with the Congressional Charter, Bylaws, Manual of Procedure, Ritual or laws and usages of the Veterans of Foreign Wars of the United States or the Bylaws of the Department having jurisdiction.

Sec. 502 - Bylaws.

The Department Convention shall adopt or may amend Bylaws governing the Department as prescribed in the Manual of Procedure, provided such Bylaws do not conflict with the Congressional Charter, Bylaws, Manual of Procedure, Ritual or laws and usages of the Veterans of Foreign Wars of the United States.





### NATIONAL LEGISLATIVE COMMITTEEMAN

#### Legislative Report February 2024

These are the key Topics from this month. Please read through these and let me know your thoughts on how we can continue to show Louisiana, that our Elected Officials are committed to our Veterans.

#### **February 5th:**

House Hearing on Survivor Outreach: The House Committee on Veterans' Affairs held an oversight hearing on gaps in VA's outreach to survivors for benefits and services. VFW Auxiliary member Gabriella Kubinyi spoke about the VFW's concerns regarding claims processing and delivery of health care, specifically in relation to mental health. She also addressed support for an increase in Dependency and Indemnity Compensation (DIC). Kubinyi said, "Every family should be fully aware that when the veteran dies, whatever benefits they were receiving will end." She continued by sharing her own survivor experience with Vet Center services and education assistance. As a former case worker for the VFW, she assisted many spouses who were not expecting or prepared for the abrupt end to compensation once their loved ones died. "Year after year, the VFW and advocates like me ask Congress to improve on a variety of survivor issues, and legislation is drafted but never receives the needed votes to enact significant changes," Kubinyi said. "I strongly urge this committee to find pathways necessary to make sure survivor benefits are taken seriously and not pushed off again for the next Congress." Read the testimony or watch the hearing, which begins at the 4:15 mark.

End-of-Life Benefits Planning: VA has a campaign designed to inform veterans and their family members about end-of-life benefits. Being aware of available benefits and services before a veteran passes away can make it easier to navigate the process and plan accordingly. Learn more about resources and options for yourself and your family.

MIA Update: The Defense POW/MIA Accounting Agency announced two burial updates for service members who have been missing and unaccounted for from World War II. Returning home for burial with full military honors are:

#### February 12th:

#### VFW, Senators, and Partners Support Afghan:

The VFW hosted Sens. Amy Klobuchar, Jerry Moran, Richard Blumenthal, and Chris Coons, along with other veteran organization partners at the VFW Washington Office for a press conference addressing the need to help Afghans who assisted U.S. troops. The participants called on all lawmakers to support our wartime Afghan allies by voting in favor of an amendment to the legislation.

#### VFW Updates County Service Officers on Claim:

VFW Washington Office Executive Director Ryan Gallucci joined the National Association of County Veterans Service Officers (NACVSO) conference to discuss the scourge of predatory Claim Sharks, and ways the VFW and NACVSO's network of accredited representatives can work more closely to provide quality claims representation for veterans. The VFW accredits thousands of county service officers around the country to help reach communities so veterans can easily access their earned benefits. NAVCSO leaders have worked

with the VFW on the Claim Sharks issue and asked for an update before advocating on Capitol Hill.

Senate Hearing on Vet Centers Supporting Mental

Health: The Senate Committee on Veteran's Affairs held an oversight hearing on how Vet Centers support the mental health needs of service members, veterans, and their families. The witness panel consisted of two representatives from VA and one from the Government Accountability Office. "Due to recent efforts by this committee, more veterans are eligible for services at Vet Centers than ever before. That's why it's critically important the Vet Center program is delivering high-quality services to the veterans who utilize it," said Chairman Jon tester.

#### **February 19th:**

**GI Bill Stifled by Overregulation:** VFW National Legislative Deputy Director Kristina Keenan spoke on a legislative panel at the midwinter meeting of the National Association of State Approving Agencies. These agencies have responsibility to review, approve, and monitor all programs and schools to ensure quality education for those using VA benefits such as the GI Bill. Keenan presented the VFW's concern that overregulation has caused too many schools to stop participating in the GI Bill program due to increasingly burdensome requirements. She also stressed the need for student veterans who take some or all college courses online to receive a more realistic monthly housing allowance, currently set at half the national average. The VFW supports increasing this amount to ensure that veterans do not experience housing insecurity while pursuing an education.

VA Focus on Pacific Areas: The VFW National Veterans Service, in partnership with the Department of the Pacific Areas, hosted a virtual benefit forum for veterans living overseas. Andrew Szymczak, VA's program management officer, presented helpful information for how veterans can best navigate the VA Foreign Medical Program, and fielded numerous questions from the audience. Should you have questions on this topic, please reach out to a VFW accredited representative.

**Veteran Hearings in the House:** The House Committee on Veterans' Affairs held four hearings on various issues facing veterans and one on VA itself. The full committee held an oversight hearing on reports of sexual harassment at VA. Subcommittee hearings included a deep dive into the VA Home Loans program, use of artificial

intelligence, the Electronic Health Record upgrade, and VA's spending in compensation and pension programs. Watch the hearings.

#### February 26th:

Independent Budget Released: Leading veterans service organizations — Veterans of Foreign Wars (VFW), DAV (Disabled American Veterans), and Paralyzed Veterans of America (PVA) — have released The Independent Budget Recommendations for the Department of Veterans Affairs for Fiscal Years 2025-2026. This report serves as a roadmap to ensure VA is fully funded and capable of carrying out its mission to serve veterans and their families, both now and in the future. "While this year's Independent Budget is once again complete, it is now imperative that Congress and VA work together, along with veterans service organizations and other stakeholders, to make the needs and interests of all veterans a top priority," said VFW Washington Office Executive Director Ryan Gallucci. "We have co-authored this report and offered budgetary recommendations to ensure the timely delivery of specialized health care and earned benefits for the men and women who served." Read the report.


VA Direct Deposit Consolidation: Starting April 20, 2024, VA will no longer send benefit payments for veterans or family members to more than one bank account. This is due to an IT modernization effort by VA for its GI Bill payment system. This change will impact approximately 50,000 students who receive the GI Bill and other VA benefits in separate direct deposit accounts. VA is sending weekly emails and text messages to this group of veterans and beneficiaries informing them of the upcoming change and asking them to select one bank account going forward. If students do not consolidate their bank accounts by April 20, VA will continue to send payments but will designate the non-education benefit payment account as the primary bank account. Read more for details on how to choose a single bank account for direct deposit.

Veterans Upward Bound is one of eight TRIO programs. This TRIO program encourages veterans to enroll in college, and it helps them develop the tools they need to succeed.

#### What does Veterans Upward Bound do?

Here are some of the ways that Veterans Upward Bound programs help and support veterans.

- Instruction in mathematics, science, foreign language, English composition, and literature
- Refresher courses for veterans who graduated from high school, but who put off college in favor of service
- Tutoring and academic counseling
- Assistance with securing education benefits through the Veterans Administration, as well as through other local and state agencies
- Guidance regarding GED and alternative education programs
- Mentoring programs
- Help completing financial aid applications

I pray that this message finds each of you in good times. Recently, our State had the pleasure of hosting the VFW Auxiliary National President for a few days who just happens to be a VFW member as well as the Auxiliary. When she addressed those attending her dinner towards the end of her three days she challenged us to do everything to end veteran suicide. In this month's issue of the vfw magazine there was an article entitled "VA report shows slight increase in veteran suicide" shows that this is a task each of us needs to take up.

After 25.5 years serving in uniform I like many of you have lost multiple fellow soldiers in different ways. Some were in combat, some accidents, some due to old age, and some to injuries. Each time I lost a soldier to suicide and addressed my troops a lead with the same three points. First, that suicide is a permanent solution to temporary problems, Second, that I am only a call or text or email away and would much rather listen to your problems than give a eulogy, and third that after I wondered what more I could have done. Suicide effects more people than we can imagine. In conclusion if you or any of our members need an ear to listen reach out to me

#### SURGEON'S MESSAGE

Greeting Comrades,

It is hard to believe that February is already over. I Hope that everyone was able to safely enjoy all the Mardi Gras festivities around the state of Louisiana!

As we get a start on March, remember we observe Daylight Savings Time on March 10th! Get that jump into Spring and warmer weather! As stated in last month's Mail Call article, with warm weather coming, it brings with it the dangers of Heat Exhaustion, Heat Stroke and Dehydration. However, there are other dangers that exist when warmer weather moves in, insects! Here are some tips if you are stung by either a flying insect or our Southern mound dwelling enemies... the Fire Ant.

#### **Flying Insects**

• While outdoors you are at risk of being stung by flying insects (bees, wasps, and hornets) and fire ants. While most stings cause only mild discomfort, some may result in severe allergic reactions that require immediate medical care and may cause death.

#### ✓ First Aid:

If you, a friend, or a loved one are stung by a flying insect:

- o Have someone stay with the person to be sure that they do not have an allergic reaction.
- o Wash the site with soap and water.
- o Remove the stinger using gauze wiped over the area or by scraping a fingernail, or even a credit card, over the area. Never squeeze the stinger or use tweezers.
- o Apply ice to reduce swelling.
- o Do not scratch the sting as this may increase swelling, itching, and risk of infection.

#### √ Protect Yourself

- o Wear light-colored, smooth-finished clothing.
- o Avoid perfumed soaps, shampoos, and deodorants.

#### ✓ Do not wear cologne or perfume.

- o Wear clean clothing and bathe daily.
- o Wear clothing to cover as much of the body as possible.
- o Avoid flowering plants when possible.
- o Keep all areas clean. Many insects are attracted to discarded food.
- o Remain calm and still if a single stinging insect is flying around. (Swatting may cause it to sting.)
- o If attacked by several stinging insects, run to get away. (Bees release a chemical when they sting, which attracts other bees.

#### √ Go indoors.

- ✓ Shaded areas are better than open areas.
- ✓ Do not jump into water. Some insects (ex. Africanized honeybees) are known to hover above the water.
  - o If an insect is inside your vehicle, stop slowly, and open all the windows.
  - o Anyone with a history of severe allergic reactions to insect bites or stings should carry an epinephrine auto-injector (Epi pen) and wear medical ID jewelry stating their allergy.

#### Fire Ants

• Fire ants bite and sting. They are aggressive when stinging and inject venom, which causes a burning sensation. Red bumps form at the sting, and within a day or two they become white fluid-filled pustules.

#### √ First Aid

- o Rub off ants briskly, as they will attach to the skin with their jaws.
- o Antihistamines may help.

#### √Follow packaging directions.

#### **✓Drowsiness may occur.**

o Seek immediate medical attention if a sting causes severe chest pain, nausea, severe sweating, loss of breath, serious swelling, or slurred speech.

#### ✓ Protect Yourself

- o Do not disturb ant mounds.
- o Be careful when lifting items (including animal carcasses) off the ground, as they may be covered in ants.

  Lastly, but not least, I am running for the VFW, Department of Louisiana Jr. Vice Commander for the VFW,
- o Fire ants may be found on trees and in water, so always look over the area before starting to work.
- o Tuck pants into socks or boots.
- o Anyone with a history of severe allergic reactions to insect bites or stings should carry an epinephrine autoinjector (Epi pen) and wear medical ID jewelry stating their allergy.

Insect stings can result in any of the following symptoms:

- ✓ Pain
- ✓ Redness
- √ Swelling (in area of sting and sometimes beyond)
- √ Flushing
- √ Hives
- √ Itching
- √ Anaphylaxis.

How to recognize a serious allergic reaction:

- These symptoms could indicate a serious allergic reaction to insect stings. Seek first aid or emergency care if any of the following are presenting after being stung:
  - √ Tightness of the throat or upper airway
  - √ Breathing difficulty
  - √ Weakness
  - ✓ Numbness and tingling
  - √ Hives
  - √ Anxiety
  - √ Abdominal cramps, diarrhea, or vomiting
  - ✓ Signs of shock.

Lastly, but not least, I am running for the VFW, Department of Louisiana Jr. Vice Commander for the 2024-2025 year, and I would appreciate your support.

## Soldier Accounted for from WWII (Coy, J.)

WASHINGTON -

The Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army Air Force Staff Sqt. Jack W. Coy, 20, of Toledo, Ohio, killed during World War II, was accounted for Sept. 20, 2023.

In early 1944, Coy was assigned to the 703rd Bombardment Squadron, 445th Bombardment Group, 8th Air Force in the European Theater. On Feb 24, Coy, a tail gunner onboard a B-24J "Liberator", was killed in action when his plane was hit by heavy antiaircraft fire over Gotha, Germany. One of the surviving crewmembers reported seeing the plane on fire and in a steep dive, before eventually exploding on the ground. While two crewmembers survived, the others, including Coy, were killed in the incident. German forces garrisoned in the area documented the crash site north of Leimbach Bahnhof, near Bad Salzungen, Germany. After the crash, German troops recovered the remains of the ball turret gunner and buried them in a local cemetery. The other six crewmembers, including Coy, were unaccounted for following the war.

In March 1952, the American Graves Registration Command (AGRC), the organization that searched for and recovered fallen American personnel in the European Theater, took custody of comingled unidentified remains recovered from Bad Salzungen Cemetery. These remains, X-9093 Griesheim Mausoleum (X-9093), X-9094 Griesheim Mausoleum (X-9094), and X-9095 Griesheim Mausoleum (X-9095), were believed to be those belonging to Staff Sgt. Coy's downed aircraft. At the time, identification of these remains was not possible, and they were interred in the Ardennes America Cemetery, Belgium.

In June 2021, DPAA historians and American Battle Monuments Commission personnel, exhumed X-9093, X-9094, and X-9095 from Ardennes American Cemetery and transferred them to the DPAA Laboratory for analysis and identification.

To identify Coy's remains, scientists from DPAA used anthropological analysis. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) analysis.

Coy's name is recorded on the Tablets of the Missing at Henri-Chapelle American Cemetery, Hombourg, Belgium, along with others still missing from WWII. A rosette will be placed next to his name to indicate he has been accounted for.

SSgt. Coy will be buried in Oregon, Ohio, on a date to be determined.

# Soldier Accounted for from WWII (Hartwick, E.)

WASHINGTON -

The Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army Tech. 4th Grade (TECH4) Elmo F. Hartwick, 38, of Onaga, Kansas, killed during World War II, was accounted for Aug. 21, 2023.

In June 1944, Hartwick was assigned to Company C, 149th Engineer Combat Battalion in the European Theater. On June 6, Hartwick was aboard Landing Craft Infantry (Large) 92, along with roughly 200 other servicemembers, enroute to land on Omaha Beach, in Normandy, France. As LCI-92 steamed toward the shore, it struck an underwater mine which caused the craft to burst into flames. The craft was also hit by enemy artillery fire, causing an explosion that ignited the ships fuel stores and instantly killed everyone in the troop compartment. Due to the urgency of the situation, it was impossible for others to search for survivors. Hartwick's remains were not accounted for after the war.

Around June 10, members of the 500<sup>th</sup> Medical Collecting Company examined the wreckage of LCI-92 and noted the burnt remains of servicemen in the troop compartment, where Hartwick and others were last seen. American Graves Registration Command (AGRC), the organization that searched for and recovered fallen American personnel in the European Theater, removed small amounts of remains from LCI-92 and buried them in the United States Military Cemetery (USMC) St. Laurent-sur-Mer.

Beginning in 1946, AGRC analyzed the remains found in LCI-92, segregating them into four separate Unknowns (X-53, X-83, X-83B, and X-83C). Despite their efforts, AGRC were unable to identify the Unknowns at the time and they were interred in Normandy American Cemetery, an American Battle Monuments Commission site in Normandy, France.

In June and August 2021, the Department of Defense and ABMC officials exhumed the comingled remains of the four Unknowns and transferred them to the DPAA Laboratory for analysis.

To identify Hartwick's remains, scientists from DPAA used anthropological analysis. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) analysis.

Hartwick's name is recorded on the Walls of the Missing at Normandy American Cemetery in Colleville-sur-Mer, France, along with others still missing from WWII. A rosette will be placed next to his name to indicate he has been accounted for.

TECH4 Hartwick will be buried in Onaga, Kansas, on a date to be determined.

# Soldier Accounted for from Korean War (Patten, C.)

#### WASHINGTON -

The Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army Cpl. Charles R. Patten, 24, of Lebanon, Missouri, killed during the Korean War, was accounted for June 7, 2023.

In July 1950, Patten was a member of Headquarters & Headquarters Company, 34th Infantry Regiment, 24th Infantry Division. He went missing in action after his unit was forced to retreat from the vicinity of Taejon, South Korea, on July 20. Due to the fighting, his body could not be recovered at that time, and there was never any evidence that he was a prisoner of war. The Army issued a presumptive finding of death on Dec. 31, 1953.

After regaining control of Taejon in the fall of 1950, the Army began recovering remains from the area and temporarily interring them at the United Nations Military Cemetery (UNMC) Taejon. One set of remains recovered during this period was designated Unknown X-2 Taejon. A tentative association was made between X-2 and Patten, but definitive proof could not be found, and X-2 was determined to be unidentifiable. The remains were sent to Hawaii where they were buried at the National Memorial Cemetery of the Pacific, known as the Punchbowl, in Honolulu.

In July 2018, the DPAA proposed a plan to disinter 652 Korean War Unknowns from the Punchbowl. On February 24, 2020, DPAA disinterred Unknown X-2 as part of Phase Two of the Korean War Disinterment Project and sent the remains to the DPAA laboratory, for analysis.

To identify Patten's remains, scientists from DPAA used dental and anthropological analysis, as well as chest radiograph comparison and circumstantial evidence. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) analysis.

Patten's name is recorded on the Courts of the Missing at the Punchbowl, along with the others who are still missing from the Korean War. A rosette will be placed next to his name to indicate he has been accounted for.

Cpl. Patten will be buried in Lawson, Missouri, on a date to be determined.

# Marine Accounted for from WWII (Hammett, H.)

WASHINGTON -

The Defense POW/MIA Accounting Agency (DPAA) announced today that Marine Corps Sgt. Harold Hammett, 24, killed during World War II, was accounted for on Sept 25, 2023.

Originally born in Avery, Mississippi, Sgt. Hammett enlisted into the United States Marine Corps in San Francisco, California, in 1940. By November 1943, Hammett was a member of L Company, 3rd Battalion, 2nd Marine Regiment, 2nd Marine Division, Fleet Marine Force, which landed against stiff Japanese resistance on the small island of Betio in the Tarawa Atoll of the Gilbert Islands, in an attempt to secure the island. Over several days of intense fighting at Tarawa, approximately 1,000 Marines and Sailors were killed and more than 2,000 were wounded, while the Japanese were virtually annihilated. Hammett is believed to have been killed while his unit attempted to secure Red Beach 2 on Nov. 20, 1943. His remains were not identified after the war.

In 1946, the 604th Quartermaster Graves Registration Company centralized all of the American remains found on Tarawa at Lone Palm Cemetery for later repatriation. However, almost half of the known casualties were never found. No recovered remains could be associated with Hammett, and, in November 1949, a Board of Review declared him "non-recoverable." Unknown remains designated X-247 were recovered from Cemetery 11, along with Unknown X-251. Initially these remains were considered to possibly belong to Sgt. Hammett, but at the time an association could not be made. The remains recovered were interred in the National Memorial Cemetery of the Pacific, also known as the Punchbowl, in Hawaii.

In late 2017, X-247 was disinterred from the Punchbowl and transferred to the DPAA Laboratory for analysis and identification.

To identify Hammett's remains, scientists from DPAA used anthropological analysis, as well as circumstantial and material evidence. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) analysis.

Hammett's name is recorded on the Courts of the Missing at the National Memorial Cemetery of the Pacific along with the others still missing from World War II. A rosette will be placed next to his name to indicate he has been accounted for.

Hammett will be buried in Hattiesburg, Mississippi, on Feb 16, 2024.

# Pilot Accounted for from WWII (Corson, D.)

WASHINGTON D.C. -

The Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army Air Forces 1st Lt. Dan W. Corson, 27, of Middletown, Ohio, killed during World War II, was accounted for Sept. 22, 2023.

In December of 1942, Corson was assigned to the 401st Bombardment Squadron, 91st Bombardment Group (Heavy), Eighth Air Force. On December 20, Corson was co-piloting a B-17F "Flying Fortress," nicknamed *Danellen*, when it was struck by anti-aircraft fire after a bombing raid on a German aircraft factory at Romilly-sur-Seine, France. Corson's aircraft was last seen spinning towards the ground, crashing near the village of Bernières-sur-Seine, France. Only one airman parachuted successfully, while the other eight crew members, including Corson, were still on board. A villager witnessed the crash and confirmed there was only one survivor. The War Department issued a finding of death for 1st Lt. Corson on Dec. 20, 1943.

Beginning in 1946, the American Graves Registration Command (AGRC), Army Quartermaster Corps, was the organization tasked with recovering missing American personnel in the European Theater. Following the war, the AGRC disinterred four sets of remains later designated as X-83, X-84, X-85, and X-86 St. Andre from Evreux cemetery. They were unable to identify the remains and were interred at the Normandy American Cemetery.

In 2011, a family member of one of the *Danellen* crew contacted the Department of Defense after visiting the crash site and interviewing a witness who had artifacts belonging to the *Danellen*. In April 2011, DPAA historians re-analyzed the unknowns associated with the crew and determined there was enough evidence to pursue the case. In October that year, a DPAA Investigation Team traveled to Bernières-sur-Seine to interview the witness and learned the crash site was completely destroyed. In March 2019, the Department of Defense and the American Battle Monuments Commission (ABMC) exhumed the unknown remains designated X-83, X-85, and X-86 St. Andre believed to be associated with the crew of the *Danellen*, including 1st Lt. Corson, from Normandy American Cemetery.

To identify Corson's remains, scientists from DPAA used anthropological analysis. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) and Y-chromosome DNA (Y-STR) analysis.

Corson's name is recorded on the memorialized on the Wall of the Missing at Cambridge American Cemetery, an American Battle Monuments Commission site in Cambridge, England, along with others still missing from WWII. A rosette will be placed next to his name to indicate he has been accounted for.

Corson will be buried in Middletown, Ohio, on a date to be determined.

# USS Oklahoma Sailor Accounted for from WWII (Robertson, J.)

WASHINGTON D.C. -

The Defense POW/MIA Accounting Agency (DPAA) announced today that Navy Seaman 2nd Class (S2c) Joseph M. Robertson, 18, of Cincinnati, Ohio, killed during World War II, was accounted for on June 18, 2020.

On Dec. 7, 1941, Robertson was assigned to the battleship USS Oklahoma, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft. The USS Oklahoma sustained multiple torpedo hits, which caused it to quickly capsize. The attack on the ship resulted in the deaths of 429 crewmen, including Robertson.

From December 1941 to June 1944, Navy personnel recovered the remains of the deceased crew, which were subsequently interred in the Halawa and Nu'uanu Cemeteries.

In September 1947, tasked with recovering and identifying fallen U.S. personnel in the Pacific Theater, members of the American Graves Registration Service (AGRS) disinterred the remains of U.S. casualties from the two cemeteries and transferred them to the Central Identification Laboratory at Schofield Barracks. The laboratory staff was only able to confirm the identifications of 35 men from the USS Oklahoma at that time. The AGRS subsequently buried the unidentified remains in 46 plots at the National Memorial Cemetery of the Pacific, known as the Punchbowl, in Honolulu. In October 1949, a military board classified those who could not be identified as non-recoverable, including Robertson.

Between June and November 2015, DPAA personnel exhumed the USS Oklahoma Unknowns from the Punchbowl for analysis.

To identify Robertson's remains, scientists from DPAA used dental and anthropological analysis. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA), Y chromosome DNA (Y-STR), and autosomal DNA (auSTR) analysis.

Robertson's name is recorded on the Walls of the Missing at the Punchbowl, along with the others who are missing from WWII. A rosette will be placed next to his name to indicate he has been accounted for.

Robertson will be buried on July 9, 2024, in Arlington National Cemetery.

# Pilot Accounted for from WWII (Marrah, J.)

WASHINGTON D.C. -

The Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army Air Forces 2nd Lt. James H. Marrah, 22, of London, Ohio, killed during World War II was accounted for August 3, 2023.

In the summer of 1943, Marrah served with the 415th Bombardment Squadron (Heavy), 98th Bombardment Group (Heavy), 9th Air Force. On Aug. 1, 1943, the B-24 Liberator aircraft on which Marrah was serving as a co-pilot, crashed as a result of enemy anti-aircraft fire during Operation TIDAL WAVE, the largest bombing mission against the oil fields and refineries at Ploiesti, north of Bucharest, Romania. His remains were not identified following the war. The remains that could not be identified were buried as Unknowns in the Hero Section of the Civilian and Military Cemetery of Bolovan, Ploiesti, Prahova, Romania.

Following the war, the American Graves Registration Command (AGRC), the organization that searched for and recovered fallen American personnel, disinterred all American remains from the Bolovan Cemetery for identification. The AGRC was unable to identify more than 80 unknowns from Bolovan Cemetery, and those remains were permanently interred at Ardennes American Cemetery and Henri-Chapelle American Cemetery, both in Belgium.

In 2017, DPAA began exhuming unknowns believed to be associated with unaccounted-for airmen from Operation TIDAL WAVE losses. These remains were sent to the DPAA Laboratory for examination and identification.

To identify Marrah's remains, scientists from DPAA used anthropological analysis, as well as circumstantial evidence. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) analysis and autosomal DNA (auSTR).

Marrah's name is recorded on the Tablets of the Missing at the Florence American Cemetery, an American Battle Monuments Commission site in Impruneta, Italy, along with others still missing from WWII. A rosette will be placed next to his name to indicate he has been accounted for.

Marrah will be buried in London, Ohio, on a date to be determined.

# Airman Accounted for from WWII (Seifreid, H.)

WASHINGTON D.C. -

The Defense POW/MIA Accounting Agency (DPAA) announced today that Army Air Forces Tech. Sgt. Harold L. Seifreid, 31, of Philadelphia, Pennsylvania, killed during World War II, was accounted for on Nov. 21, 2023.

In December 1943, Seifreid was a member of the 436th Bombardment Squadron, 7th Bombardment Group during World War II. On Dec. 1, he was serving as the radio operator onboard a B-24J Liberator bomber while on a bombing mission from Panagarh, India, to the Insein Railroad Yard north of Rangoon, Burma. After reaching the designated target, Seifreid's plane was reportedly hit by anti-aircraft fire, causing the left wing to burst into flames. Witnesses from another aircraft noted seeing Seifreid's aircraft enter a steep dive while disappearing below the clouds. It was noted that 3 enemy aircraft were also seen following the crippled plane into the clouds, and no further contact was made with the Liberator. The remains of the crew were not recovered or identified after the war, and they were all later declared Missing In Action.

In 1947 the American Grave Registration Service (AGRS) recovered the remains of what they believed to be eight individuals involved in a potential B-24 Liberator crash near Yodayadet, Burma. According to local witnesses, there were no survivors from this aviation loss and Japanese forces had instructed local villagers to bury the remains in two large graves. The AGRS designated the remains recovered from these graves as Unknowns X-505A, X-505B, X-505C, X-505D, X-505E, X-505F, X-505G, and X-505H Barrackpore (X-505A-H). The remains could not be scientifically identified at the time and were interred as Unknowns in the National Memorial Cemetery of the Pacific (NMCP), Honolulu, Hawaii, also known as the Punchbowl.

In early 2019, DPAA received a family disinterment request for Unknown X-505A-H based on past attempts to associate the remains with other unresolved losses from southern Burma. DPAA historians reviewing the associated files believed a more likely association for the remains was possible in X-505A-H. The Department of Defense approved the disinterment request, and in October, 2020, DPAA personnel exhumed the remains from NMCP where they were accessioned into the DPAA laboratory for analysis.

To identify Seifreid's remains, scientists from DPAA used dental and anthropological analysis, as well as circumstantial and material evidence. Additionally, the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) analysis.

Seifreid's name is recorded on the Walls of the Missing at the Manila American Cemetery and Memorial, an American Battle Monuments Commission site in the Philippines, along with the others missing from WWII. A rosette will be placed next to his name to indicate he has been accounted for.

Seifreid will be buried in Marana, Arizona, on a date to be determined.

# Airman Accounted for from WWII (Leukering, W.)

WASHINGTON D.C. -

The Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army Air Forces Tech Sgt. William L. Leukering, 28, of Metropolis, Illinois, killed during World War II, was accounted for March 20, 2023.

In the summer of 1944, Leukering was assigned to the 816th Bomber Squadron (Heavy), 483rd Bomber Group (Heavy), 15th Air Force based. Leukering was a radio operator on a B-17G Flying Fortress that was struck by enemy anti-aircraft during a bombing raid on German air defense installations in Memmingen, Germany. Due to the damage to the B-17G the pilot ordered the crew to bail out. Six of the airmen parachuted successfully while the other five crew members including Leukering were believed to still be on board. The surviving crew witnessed the aircraft explode in an area south of Memmingen, Germany.

Leukering's body was not recovered, and the Germans never reported him as a prisoner of war. The War Department issued a finding of death on July 19, 1945.

Beginning in 1946, the American Graves Registration Command (AGRC), Army Quartermaster Corps, was the organization tasked with recovering missing American personnel in the European Theater. In 1946, AGRC investigators searched the area of the crash site, they discovered two sets of remains however neither were associated with Leukering. He was declared non-recoverable July 26, 1951.

In 2012 a German researcher notified Department of Defense investigators to an aircraft crash site near Kimratshofen, Germany, possibly associated to Leukering's B-17. This information subsequently led to an investigation in 2013 and, excavation efforts in 2018. The excavation team located possible human remains and material evidence.

In 2019, DPAA partner teams from the University of New Orleans, and Cranfield University, continued work at the Kimratshofen site, recovering additional material, which was also transferred to the DPAA laboratory.

To identify Leukering's remains, scientists from DPAA used dental and anthropological analysis. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) analysis.

Leukering's name is recorded on the Walls of the Missing at the Epinal American Cemetery an American Battle Monuments Commission site in Epinal, France., along with others still missing from WWII. A rosette will be placed next to his name to indicate he has been accounted for.

Leukering will be buried in Round Knob, Illinois, on a date to be determined.

# Soldier Accounted for from Korean War (Norris, A.)

Washington -

The Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army CPL Adin C. Norris Jr., 21, of Kansas City, Missouri, killed during the Korean War, was accounted for Dec. 5, 2022.

In July 1950, Norris was a member of K Company, 3rd Battalion, 34th Infantry Regiment, 24th Infantry Division. He was reported missing in action on July 20 after his unit sustained heavy casualties while withdrawing from Taejon, South Korea. Due to the fighting, his body could not be recovered at that time, and there was never any evidence that he was a prisoner of war. The Army issued a presumptive finding of death on Dec. 31, 1953.

After regaining control of Taejon in the fall of 1950, the Army began recovering remains from the area and temporarily interring them at the United Nations Military Cemetery (UNMC) Taejon. One set of remains recovered during this period was designated Unknown X-266 Taejon. After extensive analysis by the Central Identification Unit-Kokura in Japan was unable to identify X-266, the remains were declared unidentifiable. They were later sent to Hawaii where they were buried at the National Memorial Cemetery of the Pacific, known as the Punchbowl, in Honolulu, with other Korean War Unknowns.

In July 2018, the DPAA proposed a plan to disinter 652 Korean War Unknowns from the Punchbowl. On July 15, 2019, DPAA disinterred Unknown X-266 as part of Phase Two of the Korean War Disinterment Project and sent the remains to the DPAA laboratory for analysis.

To identify Norris's remains, scientists from DPAA used dental and anthropological analysis, as well as and circumstantial evidence. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) analysis.

Norris's name is recorded on the Courts of the Missing at the Punchbowl, along with the others who are still missing from the Korean War. A rosette will be placed next to his name to indicate he has been accounted for.

Norris will be buried in the National Memorial Cemetery of the Pacific on a date to be determined.

## USS Oklahoma Sailor Accounted for from WWII (Schleiter, W.)

Washington -

The Defense POW/MIA Accounting Agency (DPAA) announced today that Fireman First Class (F1c) Walter F. Schleiter, 22, of Massillon, Ohio, killed during World War II, was accounted for on May 18, 2018.

On Dec. 7, 1941, Schleiter was assigned to the battleship USS *Oklahoma*, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft. The USS *Oklahoma* sustained multiple torpedo hits, which caused it to quickly capsize. The attack on the ship resulted in the deaths of 429 crewmen, including Schleiter.

From December 1941 to June 1944, Navy personnel recovered the remains of the deceased crew, which were subsequently interred in the Halawa and Nu'uanu Cemeteries.

In September 1947, tasked with recovering and identifying fallen U.S. personnel in the Pacific Theater, members of the American Graves Registration Service (AGRS) disinterred the remains of U.S. casualties from the two cemeteries and transferred them to the Central Identification Laboratory at Schofield Barracks. The laboratory staff was only able to confirm the identifications of 35 men from the USS *Oklahoma* at that time. The AGRS subsequently buried the unidentified remains in 46 plots at the National Memorial Cemetery of the Pacific (NMCP), known as the Punchbowl, in Honolulu. In October 1949, a military board classified those who could not be identified as non-recoverable, including Schleiter.

Between June and November 2015, DPAA personnel exhumed the USS *Oklahoma* Unknowns from the Punchbowl for analysis.

To identify Schleiter's remains, scientists from DPAA used dental and anthropological analysis. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) analysis.

Schleiter's name is recorded in the Courts of the Missing at the Punchbowl, along with the others who are missing from WWII. A rosette will be placed next to his name to indicate he has been accounted for.

Schleiter will be buried on April 11, 2024, in Bridgeville, Pennsylvania.

# Pilot Accounted For From WWII (Deeds, J.)

WASHINGTON -

The Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army Air Forces 1st Lt. James A. Deeds, 23 of Oakland, California, killed during World War II, was accounted for Jan. 3, 2023.

In the summer of 1943, Deeds was assigned to the 345th Bombardment Squadron (Heavy), 98th Bombardment Group (Heavy), 9th Air Force. On Aug. 1, 1943, the B-24 "Liberator" bomber *Kate Smith* piloted by Deeds was hit by enemy anti-aircraft fire and crashed during Operation TIDAL WAVE, the largest bombing mission against the oil fields and refineries at Ploiesti, north of Bucharest, Romania. His remains were not identified following the war. The remains that could not be identified were buried as Unknowns in the Hero Section of the Civilian and Military Cemetery of Bolovan, Ploiesti, Prahova, Romania.

Following the war, the American Graves Registration Command (AGRC), the organization that searched for and recovered fallen American personnel, disinterred all American remains from the Bolovan Cemetery for identification. The AGRC was unable to identify more than 80 unknowns from Bolovan Cemetery, and those remains were permanently interred at Ardennes American Cemetery and Henri-Chapelle American Cemetery, both in Belgium.

In 2017, DPAA began exhuming unknowns believed to be associated with unaccounted-for airmen from Operation TIDAL WAVE losses. These remains were sent to the DPAA Laboratory at Offutt Air Force Base, Nebraska, for examination and identification.

To identify Deeds' remains, scientists from DPAA used anthropological analysis. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA), and Y chromosome DNA (Y-STR) analysis.

Deeds name is recorded on the Tablets of the Missing at the Florence American Cemetery, an American Battle Monuments Commission site in Impruneta, Italy, along with others still missing from WWII. A rosette will be placed next to his name to indicate he has been accounted for.

Deeds will be buried in San Diego, California, on a date to be determined.

# Soldier Accounted for from WWII (Pitsor, R.)

#### WASHINGTON -

The Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army Pfc. Richard G. Pitsor, 18, of Ft. Bayard, New Mexico, who was captured and died as a prisoner of war during World War II, was accounted for March 20, 2023.

In late 1941, Pitsor was a member of G Company of the 200th Coast Artillery Regiment, when Japanese forces invaded the Philippine Islands in December. Intense fighting continued until the surrender of the Bataan peninsula on April 9, 1942, and of Corregidor Island on May 6, 1942.

Thousands of U.S. and Filipino service members were captured and interned at POW camps. Pitsor was among those reported captured when U.S. forces in Bataan surrendered to the Japanese. They were subjected to the 65-mile Bataan Death March and then held at the Cabanatuan POW camp. More than 2,500 POWs perished in this camp during the war.

According to prison camp and other historical records, Pitsor died Aug. 28,1942, and was buried along with other deceased prisoners in the local Cabanatuan Camp Cemetery in Common Grave 305.

Following the war, American Graves Registration Service (AGRS) personnel exhumed those buried at the Cabanatuan cemetery and relocated the remains to a temporary U.S. military mausoleum near Manila. In 1947, the AGRS examined the remains in an attempt to identify them. Three of the sets of remains were recovered from Common Grave 305 but were declared unidentifiable. The unidentified remains were buried at the Manila American Cemetery and Memorial (MACM) as Unknowns.

In January 2019, the remains associated with Common Grave 305 were disinterred and sent to the DPAA laboratory at Joint Base Pearl Harbor-Hickam, Hawaii, for analysis.

To identify Pitsor's remains, scientists from DPAA used dental and anthropological analysis. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) analysis.

Although interred as an Unknown in MACM, Pistor's grave was meticulously cared for over the past 70 years by the American Battle Monuments Commission (ABMC).

Pitsor will be buried in Ft. Bayard, New Mexico, on a date to be determined.

### National General Orders Number 8

### General Orders No. 8

2023-24 Series



#### 1. INSTALLING OFFICERS:

Installing officers will see that the provisions of Section 216 of the National Bylaws and the Manual of Procedure are properly carried out and that all officers are members in good standing and qualified to hold office prior to installing Post officers for the current year. Post officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed.

Post Election Reports must be submitted following Post election of officers in April and no later than June 1 to the National Headquarters. We highly encourage all Post Quartermasters to use the online Election Report process featured in the Online Membership System (OMS). Post Election Reports received electronically will be forwarded to the Department Headquarters.

2. Attention of Post Commanders is directed to Section 222 of the National Bylaws and the Manual of Procedure, which provides that each Post will pay, in advance, a National Convention registration fee of twenty-five dollars (\$25) which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Each additional delegate attending the National Convention will pay a ten dollar (\$10) delegate fee.

Posts are encouraged to register their Post delegate online through the Online Membership System (OMS) or by submitting their National Convention Post and Delegate Registration form that was mailed to all Posts as part of the Election Report/Convention Registration mailing that went out in February. Advanced registration for the 125th National Convention should be mailed with each delegate's name and address to: Convention Registration, 406 W. 34th Street, Kansas City, MO 64111.

3. Pursuant to Section 403 of the National Bylaws and the Manual of Procedure, each District shall hold an annual District convention for the purpose of electing District officers, such convention to be held not less than ten (10) days nor more than seventy-five (75) days prior to the convening of the Department convention. District officers shall not assume the duties of their office until the Department Commander is installed. District officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed in accordance with Section 416 of the Manual of Procedure.

#### 4. LOYALTY DAY AND MEMORIAL DAY OBSERVANCE:

Section 223 of the National Bylaws and the Manual of Procedure provides that each Post shall make the necessary arrangements for proper observance of Loyalty Day and Memorial Day. Officers should see that suitable grave markers, wreaths and flags of the United States are placed on the graves of deceased veterans.

### 5. "BUDDY"® POPPIES DISTRIBUTION:

The distribution of VFW "Buddy" Poppies will be conducted according to the provisions set forth in Section 711 of the National Bylaws and the Manual of Procedure. Department, District, County Council and Post Commanders should arrange now for the distribution of Buddy Poppies in their respective areas.

In the ongoing effort to provide as much assistance as possible to those serving in the military, we recommend that proceeds or portions from this year's annual poppy distribution be designated for the purpose of providing VFW support to our military. Posts and Departments now have the opportunity to assist qualified military personnel through the VFW Veterans and Military Support Programs.

In keeping with the intent of Sections 219(a)(c) and 704(a)(c) of the Manual of Procedure "Relief Fund," this year's poppy campaign can play a direct role in demonstrating to those who are charged with protecting and defending our way of life that we appreciate and value their sacrifice.

### VFW Foundation





As we plan for the **2024 National Convention**, there will be a new design for the **VMS Lapel Pins** for **2024-25 Program year!** VMS Chairs will be able to pre-order their pins and will be able to pick them up at the convention again this year. **Departments that are delinquent will not be able to pre-order.** Request forms will be provided sometime in March/April 2024.

**DISPLAYING MILITARY SERVICE SYMBOLS.** Military service flags, insignias, etc. should be displayed in the following order (left to right as you face the flags): Army, Marine Corps, Navy, Air Force, Space Force and then Coast Guard. PROGRAMS DASHBOARD TOOL. (NOTE: Previously ALL-AMERICAN DASHBOARD) Please encourage Posts to read the 2023-24 Membership program. Military Assistance Program grants have been launched to show Departments and Posts how much in grant assistance has been received from National HQs to supplement the Unmet Needs financial grants and VFW Sport Clips Help A Hero scholarship statistics. The information charts reside in the KPI tools section.

#### SMART/MAHER VFW NATIONAL CITIZENSHIP EDUCATION TEACHER AWARD.

Nominations for this award and the judging at the Post, District and Department level (if applicable) are completed. The Department Teacher winners that are received at National Headquarters will receive a VFW National citation for both the winning teacher and their school in each grade category. The National Teacher Award winners will be announced soon.

Order the Citizenship Education Teacher Recognition Citation from VFW Store, product #4320, <a href="https://www.org/products/23980">wfwstore.org/products/23980</a>. Present to all teachers nominated at all levels for the national award.

**VOICE OF DEMOCRACY AND PATRIOT'S PEN NATIONAL AWARDS.** Every Voice of Democracy and Patriot's Pen first place Department winner will receive a National scholarship or award. The amount for the Voice of Democracy National Awards now totals \$172,000, with the top three awards being raised to \$35,000, \$21,000 and \$15,000. The Patriot's Pen National Awards total is \$55,000.

**NEW UPDATES.** VFW National Programs has updated the Fred C. Hall and Outstanding Community Service Post Award programs starting this program year. Please share this with your Community Service Chairpersons.

FRED C. HALL MEMORIAL AWARD FOR COMMUNITY SERVICE. Each year on July 1, the national Programs office will determine the top community service Posts in each conference, based off their community service reporting and total impact, from July 1 to June 30 the previous year. Your community service total impact is figured by the money spent to host and organize the community service event, plus total hours all volunteers participated, plus the mileage for all volunteers (Dollars Donated + Hours + Mileage = Total Impact).

These four Posts will be awarded the Fred C. Hall Memorial Award for Community Service and will be invited to attend the VFW National Convention. The Post Commander (or designated representative) and a guest will receive round-trip airfare, hotel accommodations for five nights, and a \$599 stipend to receive the award at the VFW National Convention.

OUTSTANDING COMMUNITY SERVICE POST OF THE YEAR. Each Department will have an OCSP winner based on total impact also. National will select based on end of year reports on July 1. Winners will also be published in the Convention program booklet and receive a street sign identifying this national award for the Post to put up in their community

"UPDATED" POW/MIA FLAG -- OFFICIAL DISPLAY DAYS. Under previous Public Law 105-85 (Nov. 16, 1997), it indicated there were only six days that federal agencies, military installations and U.S. post offices were required to display the POW/MIA flag. Now under new law, Public Law 116-67 (Feb. 21, 2020), it is required that the POW/MIA flag be flown on all days on which the flag of the United States is displayed. IRS AND VFW AWARD MONIES. The Internal Revenue Service (IRS) requires that any recipient that receives more than a \$599 award should receive a Form 1099 identifying the proceeds as taxable. This will include the VFW programs Patriot's Pen and Smart/Maher VFW National Citizenship Education Teacher Award.

### "Buddy"® Poppy

"BUDDY"® POPPY CAMPAIGN. Although we emphasize Buddy Poppies on Veterans Day and Memorial Day, it is important to realize that the distribution of Buddy Poppies should be a year-round exercise. Each time a Post participates in an activity where the public will be present, Buddy Poppies should be present as a fundraising tool and simply to recognize our fallen comrades. Where the VFW appears, Buddy Poppies should be a constant reminder that we will never forget those who have perished in the name of liberty. Just as "They Gave, Will You?" is a year-round thing, so should the distribution of VFW Buddy Poppies.

Remember that your poppies should be ordered a minimum of three (3) weeks in advance of your distribution date.

BUDDY POPPY UPDATE: National Headquarters conducted a review of the Buddy Poppy policy and procedures and implemented the following changes effective Jan. 1, 2024:

- 1) Departments must order poppies through OMS.
- 2) All claims of non-receipt of a Buddy Poppy order must be made within 90 days of the date of the order or will NOT be replaced free of charge.
- 3) All orders for the traditional Buddy Poppy, Anniversary Poppies or tin tab poppies must be placed through your Department Headquarters. Auxiliaries must go through their Post to order all poppies.
- 4) The tabs do count towards the Buddy Poppy requirement for the All-American program.
- 5) If you do not receive your order within four weeks of placing it with your Department, please contact your Department Headquarters to report you have not received your order.
- 6) All poppies are shipped within 10 days of ordering except orders placed in June and July, due to preparation for National Convention, please allow an additional five business days.

Miscellaneous items (coin cans, buttons, posters, etc.) should be ordered directly from the VFW Store at vfwstore.org/category/programs/buddypoppy or the VFW Store/Emblem and Supply Catalog.

The Manual of Procedure provides that Post relief funds may be used for programs such as Voice of Democracy, Patriot's Pen, Citizenship Education, and Community Service as long as suggestions in the chairperson's guidebooks are used as an example of promoting these programs.

Posts are further reminded that Section 711 of the Manual of Procedure provides that non-profit organizations, exempt from taxes under Section 501(a) of the Internal Revenue Code, may assist with the distribution of Buddy Poppies, provided there shall be no division of proceeds. A donation to these groups may be made from the Post general fund.

VFW SILVER, GOLD AND DIAMOND ANNIVERSARY POPPIES. The silver, gold and diamond anniversary Buddy Poppies are for Posts that are currently in their 25th, 50th or 75th anniversary years. For Posts currently in their 100th year anniversary, they can order any color and as many as they need.

Please limit your order of anniversary poppies to 1,000 to ensure stock does not run out unless you are currently in your 100th year. These are ordered through the Department in OMS and processed the same as the red poppies. Currently, we have no plans to replenish inventory due to increased cost and the small quantities we sell of the Anniversary Poppies. Based on the past four years' sales, we have sufficient inventory for the next 3.5 years of the Gold, 5 years of Diamond and 52 years of the Silver.

On Feb. 20, 2024, all Departments were notified that nominations for the John A. Biedrzycki Service Representative of the Year for 2023-24 are now being accepted.

We encourage every Department to submit a nomination to show that Department leaders are aware of the significant contributions your service office staff and service program make in your community every day.

#### ELIGIBILITY:

Eligible nominees include:

- VFW Department Service Officers
- VFW Assistant Department Service Officers
- VFW Claims Consultants/Representative/Analysts/Reviewers
- Any State or County VFW accredited representative
- Veterans Service Officers/Representatives

#### Individuals **NOT** eligible for this award are:

- VFW National Staff
- VFW Contractors
- Previous recipients of the Accredited Representative of the Year Award
- Individuals who do not have VFW accreditation

#### **SELECTION CRITERIA:**

- 1. Nominees for the annual award must have demonstrated exceptional efforts in assisting veterans and their families during the 12 months preceding the April 30 deadline.
- 2. A brief summary of no more than two pages is to be submitted which explains the who, what, when, where, and how the nominee's efforts are considered exemplary. Suggested items for consideration (but not limited to):
  - Number of individuals with VFW POAs assisted.
  - Community outreach conducted.
  - Examples of excellent customer service provided.
  - Meticulous use of Tyler Veterans Benefits (TVB) or another electronic claims processing system (specify system).
  - Submission of TIMELY monthly reports (if located in a VA regional office).
  - Number of VFW members recruited.

#### AWARDS:

Each Department Commander may nominate one eligible individual for this prestigious award. The individual who is ultimately chosen as the recipient will be provided with round-trip travel (for the winner and one guest) and two nights' hotel accommodation to attend the VFW National Convention where the award will be presented. In addition, the award recipient will receive \$599 in recognition of their accomplishments and to offset travel expenses.
