
We missed out on \$1000 by not being at 88% by 1 November. As of this morning, we sit at 79.44%. So, to receive \$1000, we need 1624 renewals, new members, or reinstate to reach the next goal from CinC is 1 February 95%, or roughly 85 members a day!! And the Department will receive \$1000!!!




Glenn R. Umberger Jr. National Council of Administration Veterans of Foreign Wars of the United States

In recognition of his service, he received two Meritorious Service Medals, 10 Army Commendation Medals, three Army Achievement Medals, two National Defense Service Medals, the Southwest Asia Service Medal with three campaign stars, Global War on Terrorism Service Medal, Armed Forces Reserve Medal with gold hourglass and "M" device, Saudi Arabian Medal for the Liberation of Kuwait, and the Kuwait Medal for the Liberation of Kuwait, among several other awards and citations.

Glenn joined the Veterans of Foreign Wars in 1993 at Post 23 in Lebanon, Pennsylvania, later transferring to Post 7155 in Trappe, Pennsylvania, where he maintains his Gold Legacy Life membership. He has served in elected and

PAGE 5 IS TO BE READ AT MEETINGS THEN POSTED

MANDATORY:

General Orders: All material in the State General Orders is directive in nature and will be read to the membership at the Post regular membership meetings each month. **Some of these have remained the same and will remain for a while longer to instill their importance to our order. New Items will be added to the General Order and will have some highlighted in Red areas.**

ARTICLE X - RULES OF ORDER

Sec. 1001 - Rules of Order Governing All Meetings.

25. The dispensation and/or consumption of alcoholic beverages or use of smoking/vaping products in VFW meeting rooms during VFW meetings are **prohibited**.

Post Commanders: If you, your Quartermaster, or Adjutant do not have an email address please designate a member of your Post, with an email address, to disseminate information from District and Headquarters. Also, please ensure the Post roster is always up to date and accurate.

General Rule 13, (a) All members who are able will stand during the offering of the prayers; (b) members will follow the action of the Chaplain or presiding officer relative to removal of caps during prayers; if uncovering, the hat shall be placed on the extended closed fingers of the right hand in such a way that the Cross of Malta is exposed and held over the heart; (c) official caps will not be worn during luncheons, banquets or other meals; (d) Official caps will be the only head covering allowed to be worn at regular meetings of the Veterans of Foreign Wars of the United States.



Although every day should be Veterans Day, Saturday, 11 November is officially Veterans Day. Show support for our fellow veterans and comrades on Veterans Day; have a ceremony, thank a veteran or just call and do a buddy check. Remember, many restaurants offer either free or discounted items on or near Veterans Day. Thanksgiving is a time to remember the things that we are thankful for; however, some veterans have a hard time around holidays, so check on each other to make sure everyone makes it through the holiday season.

Entries for Americanism, Patriots Pen, and Voice of Democracy should be to the post and posts have until 15 November to judge. Check with your district chairperson to make sure what date the entries need to be at the district level. We don't want entries not judged because they were late, so verify deadlines.

A few items I would like to address. According to Article X – Rules of Order Sec. 1001 Number 4 on page 109, "When a member rises to speak, the member shall rise and address the presiding officer. When two or more members rise to claim the floor at about the same time, the presiding officer assigns the floor to the member who appeared to have risen first and addressed the chair. Please remember to rise and address the presiding officer when you have something to discuss at the meetings."

Many posts change or cancel meetings during the holidays. Remember, to vote on the meeting change and inform the district commander, state commander and adjutant that the meeting date and/or time has changed or canceled. Send the updated information for your meeting.

Lastly, if a member or post commander is having any issues, I ask that you keep your district commander informed, as well as the state commander. When a district commander checks on you and or your post, he or she is trying to make sure you have everything that you need.



In todays world you are always in that glass house so don't be throwing stones.

Legal Counsel

• Last week the VFW sent a letter to the Department of Defense and Solicitor General in support of the Supreme Court denying certiorari in the case Atchley v. AstraZeneca UK Ltd. That case was filed under the Anti-Terrorism Act, which imposes civil liability on companies that knowingly finance terrorist attacks. The plaintiffs, Gold Star families and veterans who were killed or injured by a Shiite terrorist group in Iraq, allege certain pharmaceutical companies, including AstraZeneca, provided funding to terrorist groups in exchange for the award of contracts. Denying cert would allow Gold Star families and wounded veterans to finally begin discovery in their lawsuit. This case has been tied up in court for the past six years. Consequently, the victims haven't even had a chance to prove their claims yet. Such a delay is unconscionable for our veterans, and denying cert would allow the case to be remanded back to the District Court where it can proceed.

Administrative Operations

- Department Inspections: We are moving forward with the Department Inspection initiative for the 2023-2024 term and have plans to complete ten (10) inspections this year. The hope is that we will have the first inspection scheduled for the beginning of October and have all inspections completed by May 2024, prior to the start of Department conventions. In the coming weeks we will be reaching out to the Departments that have been selected by the Commander-in-Chief as well as the inspection team members to begin working through availability and scheduling. Additionally, the inspection team will be conducting initial and refresher training in September before we start our schedule. We look forward to another successful year of inspections and if you have any questions or concerns, please contact Quentin Carroll @vfw.org.
- There are currently 51 Posts under suspension, three of which are new. We have processed four Post consolidations pursuant to Section 209 of the National Bylaws. The organization has 5,669 chartered Posts.
- Administrative Operations is engaged in 10 Article IX Disciplinary Actions, nine Administrative Actions and 11 membership eligibility challenges.
- We have 63 Bylaws/Articles of Incorporation submissions in for review, none of which are new; current turnaround time on Bylaws/Articles of Incorporation submissions is approximately 30 days.

- Mentorship can look different at every Post. Sometimes it's easy to recognize efforts made by comrades to promote VFW institutional knowledge, we see it all the time. Sometimes it is smaller, less obvious efforts that enable the Post to thrive. Seek these comrades out and recognize them! We know that Posts with strong mentorship programs are successful. - o #StillServing Grant (SSG) This grant provides reimbursement of up to \$1,500 for expenses incurred while performing community service activities where Post/District/Auxiliary members engaged community members directly.
- o Post Assistance Grant (PAG) This grant provides reimbursement of up to \$2,500 for expenses incurred from purchasing qualifying equipment or making repairs/renovating a Post owned property.
- o Uniting to Combat Hunger (UTCH) Grant This grant provides reimbursement of up to \$1,500 for donations made to food insecurity organizations or for the purchase of food that supports a Post or Auxiliary ran food pantry.

National Legislative Service

- Joint Senate Committee Hearing on Military Transition: VFW Washington Office Executive Director Ryan Gallucci testified at a joint hearing of the Senate Committees on Veterans' Affairs and Armed Services on military to civilian transition. He explained the need to pass VFW-supported H.R. 3933/S. 2888, TAP Promotion Act, in addition to amending laws and policies that govern the DOD Transition Assistance Program (TAP), commonly referred to as TAP class. Gallucci stated, "A solid transition can set up veterans for success after service. Conversely, a failed transition could lead to devastating consequences like unemployment, homelessness, even suicide. This hearing follows a December 2022 Government Accountability Office report on TAP that indicated 70 percent of transitioning service members did not begin the class at least 365 days before separation or retirement as mandated by law. - Shortened Survivor Benefit Plan Deadline: Military retirees interested in enrolling in the Survivor Benefit Plan (SBP) must now submit their letter of intent (LOI) to the Defense Finance and Accounting Service (DFAS) by Nov. 1, 2023. Authorized by the National Defense Authorization Act for Fiscal Year 2023, the SBP Open Season began in December 2022 and ends on Jan. 1, 2024. The initial step in the enrollment process is to file a nonbinding LOI with DFAS. Once processed, individuals will be provided personalized buy-in amounts, premiums, and estimated benefits, which can then be used to make informed decisions.

- NVS Director Mike Figlioli and Executive Director Ryan Gallucci held an office call at the VFW Washington Office with the Chairman of the Board of Veterans Appeals. NVS Health leadership participated in a VHA Veteran integrated Care collaboration meeting.
- NVS Director Mike Figlioli and NVS Staff will hold the monthly VSO Update Forum at 2pm on Oct. 25, 2023, via ZOOM.
- NVS managers will meet with USAA to continue work on USAA Impact Days and provide updates on the grant process.

NATIONAL LEGISLATIVE COMMITTEEMAN

Legislative Report October 2023

These are the key Topics from this month. Please read through these and let me know your thoughts on how we can continue to show Louisiana, that our Elected Officials are committed to our Veterans.

October 2nd:

Claims Representative Access Bill Introduced: Sens. King (I-ME), Cramer (R-ND), Shaheen (D-NH), and Rounds (R-SD) have introduced S. 2888, TAP Promotion Act, to authorize accredited claims representatives to be present in DOD Transition Assistance Program (TAP) classrooms. This legislation is the companion bill to H.R. 3933 introduced by Rep. Van Orden (WI-3). The goal of these bills is to help mitigate gaps in care for transitioning service members who use the VA Benefits Delivery at Discharge program, which provides an expedited VA disability claims pathway for benefits and services. The VFW has been a long-standing supporter of this initiative as a means to reduce suicide risk among recently transitioned veterans. Read the press release.

Report on Military Barracks Released: The Government Accountability Office (GAO) released a report on its review of military barracks. The study, which was required as part of the National Defense Authorization Act for Fiscal Year 2022, found mold and raw sewage among other health, safety, and well-being concerns. GAO also found that DOD lacks reliable mechanisms to track barracks conditions and the funding spent on improvements. This report bolsters the need to pass VFW-supported H.R. 3165, Military Housing Transparency and Accountability Act. Read the report.

National Cemetery Administration Survey: VA has released a survey to determine awareness of burial options and end-of-life benefits. If you are a veteran, family member, survivor, caregiver, or friend, please take a few minutes to answer these questions so VA is better able to serve you. Take the survey.

October 9th:

Afghan Female Tactical Platoon Event: The VFW Washington Office hosted members of the Afghan Female Tactical Platoon, lawmakers, and fellow veterans groups to discuss the critical need for the passage of the Afghan Adjustment Act. This legislation would ensure a path to lawful permanent residence for those who assisted decades-long U.S. operations in Afghanistan, which aligns with the VFW resolution on this issue that was overwhelmingly passed by our membership at convention. VFW National Legislative Service Associate Director Brittany Dymond spoke at the event about the importance of honoring our allies. She stated, "The Veterans of Foreign Wars is an organization comprised of veterans who were deployed overseas to different countries. In order to accomplish our missions, we often had to rely on our allies who stood shoulder to shoulder with us in harm's way." Read more.

VFW Leadership in Europe: VFW National Commander Duane Sarmiento, Senior Vice Commander Al Lipphardt and Washington Office Executive Director Ryan Gallucci arrived in Belgium for the first stop on their two-country mission that also includes Germany. TRICARE Open Enrollment Season Coming
Soon: TRICARE Open Season will be Nov. 13 -

VFW Brings Claims Services to Korea: VFW National Veterans Service (NVS) provided critical information to major commands and transitioning service members alike. NVS Director Mike Figlioli, Deputy Director Gregg Orto, and Field Operations Assistant Director Cindy Noel paid visits to U.S. Forces Korea, Eighth U.S. Army at Camp Humphreys, and Seventh Air Force and 51st Fighter Wing at Osan Air Base. At each location, they met with the local command groups and gave briefings to service members about the VA claims process and free benefits claims assistance services. Following Korea, the NVS team headed to military commands in Hawaii. See the post.

VA Expands Maternity Care Coordination: As of Oct. 1, 2023, veterans will have access to maternity care coordinators from the beginning of pregnancy to 12 months postpartum. This is an expansion from the previous end date of eight weeks postpartum. These coordinators help veterans navigate health care inside and outside of VA, connect them with care after delivery, and ensure access to follow-up screenings. Learn more.

October 16th:

National Buddy Check Week: The first annual National Buddy Check Week is Oct.16 - Oct. 20, 2023. In this new VA program, veterans are encouraged to contact ten fellow veterans and check on how they are doing. The goal is to build peer-to-peer connections, improve mental health, and increase access to VA resources. Veteran family members, caregivers, and survivors are also encouraged to participate. Learn more.

Direct Deposit Only for VA Caregiver Stipends:

VA will no longer issue paper checks for all primary family caregivers. Enrollment as a vendor for direct deposits may be done through VA's <u>Customer Engagement Portal</u>. Caregivers will need their social security number, address, and bank routing/account numbers to complete the required form. The <u>CSP Direct Deposit Enrollment User Guide</u> provides step-by-step enrollment instructions. Learn more.

Soon: TRICARE Open Season will be Nov. 13 - Dec. 12, 2023. This is your chance to enroll or change your health care plan for the next year. If you are satisfied with your current plan, no action is necessary and your coverage will continue automatically for 2024. It is important to note that new retirees have only one year to enroll for TRICARE Prime or Select. Enrollment is not automatic for retirees. Learn more.

October 23rd:

VFW-Supported Amendment Passes Senate:

The Senate passed an amendment to the Military Construction, Veteran Affairs, and Related Agencies Appropriations Act, 2024. In July, the VFW testified in favor of H.R. 705, Veterans 2nd Amendment Protection Act, which mirrors the aforementioned bill. This amendment would block VA from automatically referring veterans with fiduciaries to the National Instant Criminal Background Check System (NICS), which prohibits the ownership of firearms. It would also require that any VA referrals to NICS must first have the order of a judge indicating that the person is a danger to themselves or others. The VFW sees this as a necessary step to ensure the right of due process for veterans. Read more.

Senate Committee Hearing on VA

Accountability: The Senate Committee on Veterans' Affairs held an oversight hearing on VA accountability and transparency. Efforts to streamline VA's ability to hire and fire employees in an efficient manner were discussed. "Accountability and transparency must be cornerstones of fulfilling VA's mission to provide high quality care and benefits to our veterans. We can all agree that bad actors at VA cannot and will not be tolerated," said Chairman Jon Tester. Watch the hearing, which begins at the 12:18 mark.

Expected COLA Increases Announced: The Social Security Administration (SSA) announced a 3.2% benefit increase for 2024. VA compensation payment rates will match the rates from SSA. Veterans can expect to see the new amounts starting with their January 2024 payment. Read more.

The Spanish-American War ended August 1898 and the Philippine Insurrection went from 1899-1902. Veterans returning home banded together creating Chapters in Ohio, Colorado, and Pennsylvania with a common goal caused by these wars or hostile actions. The early days of the VFW got a big boost at the end of World War I (WWI), when 4.6 million men returned from the war. Our government was unprepared to reintegrate and care for these men, many with physical and psychological trauma affecting these veterans for the rest of their lives. The men that were able, took up a different fight, a fight for their fellow brothers in arms, a fight started by veterans that


founded the three original states of the VFW.

Our Department was championed by one of these WWI veterans for his hard work, recruiting members, and establishing Posts for the Department charter, Samuel D. Haas, our Department's first State Commander at the age of 37. Louisiana was chartered on July 5th, 1931,



but its creation started some ten to twelve years before its charter. The earliest Post I have found was Louisiana VFW New Orleans Post 351, who's chartered date of April 6th, 1921, fell under the Department of Texas/Louisiana/Mississippi when all were combined.

The efforts of these few hundred veterans of the original ten Posts, eight belonging to Louisiana and

the remaining two to Mississippi. It was hard work just from a communications point of view. Today even though many of our veteran are embracing this technology age we are living in, few do not. Todays Internet, cell phone in our pockets, to communicate almost instantaneous, or to jump on a plane and be across country in the same day for a meeting the next, were just not believed in the 1920's.

The Communications and travel of the 1920's is something we today would find hard to navigate. Long distance phone call are a thing of the past where the only way to make one was to go through an operator or maybe more. Hopefully your party was in their office and maybe not. Their email was the telegram sent by telegraph and then you could only send or receive a message of a few sentences at a time. Flying cross country often meant flying in a plane designed to carry mail. Driving cross country usually meant taking the train. Driving over roads mainly made of dirt or shell, for local (in state) travel.

Past State Commander (PSC) Haas, by the files I have been sifting

through, communicated by telegraph, letter writing, and phone calls. I learned about the phone calls from some of the letters stating the conservations mentioned. PSC Haas was a chartered member of VFW Post 1736 in 1930 the year before our Department's establishment.


Regarding the original ten Posts that chartered our department, I am still searching to find out who they were. I have so far identified Post 351 and Post 1736. At the end of PSC Haas' year at the Second Annual Encampment, he added an additional 15 Post, ending his year with 25 Post in the Department of Louisiana. This all done with technology we today would nearly find impossible, growing and living in this age of information at our fingertips and calling someone at the touch of a button. What is most amazing is this was all done at the beginning years of The Great Depression of 1929-1939. Buying food, gas, paying mortgages, and where finding or keeping a job was paramount on the people of those days. Buying VFW caps but then cost \$5, gas traveling to conferences cost .17 cents, and about \$8 a night paying for a hotel room. These men were dedicated to a cause that the VFW


represented, where helping veterans and their families was their focus.

I tip my hat to PSC Haas' accomplishments and salute his ability to communicate the message of theirs and the generations of war veterans. The message of the 1930's and 40's were received by veterans looking to make it better for future warriors, be it men or women. They were in the VFW working for veterans rights and benefits not knowing women would one day fill the ranks in the fields, planes, or the seas. They did it for the veteran.

We are the current stewards of the VFW, and we need to find the message that resonates with this generation of veterans today. Todays conflicts create todays veterans of 18 to 25 year olds. We need to find the message and ideals that motivate them and make them want to belong to an organization they want to participate in. All this without losing what makes the VFW what it stands for.




Date of July 13, 2023 Identification

On July 13, 2023, the Defense POW/MIA Accounting Agency (DPAA) identified the remains of Private Doyle W. Sexton, missing from World War II.



Following the war, American Graves Registration Service (AGRS) personnel exhumed those deceased buried at the Cabanatuan cemetery and relocated the remains to a temporary U.S. military mausoleum near Manila. In 1947, the AGRS examined these remains in an attempt to identify them. Twelve sets of remains from Common Grave 312 were identified, while the rest were buried at the Manila American Cemetery and Memorial as Unknowns. In early 2018, the Unknown remains associated with Common Grave 312 were disinterred and sent to the DPAA laboratory for analysis, where the laboratory results and the totality of the circumstantial evidence available identified one set of disinterred remains as those of Private Sexton.

Private Sexton is memorialized on the Walls of the Missing at the Manila American Cemetery in the Philippines.

What is a "Claim Shark"?

- A Claim Shark is an individual or company that charges hefty fees to "assist" or "consult" veterans with filing their VA benefit claims – this practice is illegal!
- Claim Sharks are not VA accredited, meaning they aren't required to adhere to the
 well-established professional and ethical standards of VA accreditation, so their advice can
 often be misleading or even fraudulent.
- Like a "Loan Shark," once you're in, you can't get out, and may be subject to new and hidden fees whenever you get a new rating, no matter who does the work.

Some of their predatory practices are:

- Promising or guaranteeing an increased disability rating or percentage increase.
- Advertising expedited VA claims decisions.
- Requesting login credentials to access a veteran's personal information through secure VA websites like eBenefits or VA.gov.
- Using confusing tactics or ambiguous language to mislead claimants or coerce them into signing a contract.
- Telling veterans to forego VA exams and offering health consultations within their own network of doctors.

Overseas Departments will donate for the other programs through the link also in lieu of participation. This will automatically update daily.



SMART/MAHER VFW NATIONAL CITIZENSHIP EDUCATION TEACHER AWARD PROGRAM DEADLINE REMINDER. The deadline for the annual Teacher Award contest is quickly approaching. All teacher nominations should have been completed and submitted to a participating VFW Post by Oct. 31, 2023. A completed nomination should consist of a completed entry form with a one-page resume as a minimum or up to five-pages, including the resume, as a maximum of documentation of their teacher experience, along with a head-and-shoulder photo, if available at the time.

Each corresponding deadline for Post, District, if applicable, and Department to have their entries to the next level are as follows: Nov. 15, 2023, for completion of Post judging; Dec. 15, 2023, for completion of District judging, if applicable; Feb. 1, 2024, for completion of Department judging and their winners forwarded to National Headquarters.

NOTE: The only item the National VFW Programs Department requires is the "VFW Department Teacher Award Citation Request Form" with the entry documentation downloaded. A link will be forwarded soon to the Department Adjutant/Quartermaster to submit it to National Headquarters. You can locate additional information by logging in to wfw.org and searching under "My VFW" in the Training & Support section.

The VFW's Department Citizenship Education Teacher Award includes a citation for both the winning teacher and their school.

The VFW's National Citizenship Education Teacher Awards include: three national \$1,000 awards for the top K-5, 6-8, and 9-12 teachers for professional development expenses; \$1,000 award to each winning teacher's school; plaques for both the winning teacher and school; and an all-expense-paid trip to attend a VFW National Convention.

NEW UPDATES. VFW National Programs has updated the Fred C. Hall and Outstanding Community Service Post award programs starting this program year. Please share this with your Community Service Chairpersons.

The new programs are as follows:

FRED C. HALL MEMORIAL AWARD FOR COMMUNITY SERVICE. Each year on July 1, the national Programs office will determine the top community service Posts in each conference, based off their community service reporting and total impact, from July 1 to June 30 the previous year. Your community service total impact is figured by the money spent to host and organize the community service event, plus total hours all volunteers participated, plus the mileage for all volunteers (Dollars Donated + Hours + Mileage = Total Impact).

These four Posts will be awarded the Fred C. Hall Memorial Award for Community Service and will be invited to attend the VFW National Convention. The Post Commander (or designated representative) and a guest will receive round-trip airfare, hotel accommodations for five nights, and a \$599 stipend to receive the award at the VFW National Convention.

OUTSTANDING COMMUNITY SERVICE POST OF THE YEAR. Each Department will have an OCSP winner based on total impact also. National will select based on end of year reports on July 1. Winners will also be published in the Convention program booklet and receive a street sign identifying this national award for the Post to put up in their community.

VFW NATIONAL PUBLIC SERVANT AWARDS. All nominations, consisting of a completed Post entry form and the required documentation, should be in the hands of the local Post by Oct. 31, so they may begin their judging. Once their judging has been completed, VFW Post Safety Chairperson's are to submit up to five winning nominees (one for each career area) to their Department Headquarters for judging no later than Jan. 1.

Once judging has been completed, Departments are asked to submit their five winning nominees (one for each career area) to the VFW Programs office, by completing the "VFW Department Public Servant Award Request Form" through Formstack. VFW Programs staff will email the form link to Department Adjutants/Quartermasters prior to the deadline of Feb. 1.

VFW Programs will create citations for the following awards in each Department:

- VFW National Law Enforcement Award
- VFW National Firefighter Award
- VFW National Emergency Medical Technician Award

- VFW National 911 Dispatcher Award
- VFW National Explosive Ordnance Disposal Technician (E.O.D.T.) Award

All Department Public Servant Citations must be requested through the "VFW Department Public Servant Award Request Form" through Formstack. VFW Programs staff will email the form link to Department Adjutants and Quartermasters. Deadline for Department submissions to National is Feb. 1.

Each Department will receive their requested awards and should contact their recipients to arrange a presentation. Department Commanders may present the awards at their Department Convention, but are encouraged to also present the award in front of the recipient's peers at a professional association event, city council meeting, etc. The purpose of the second venue is to expose these VFW awards to the general public and especially other law enforcement, firefighters, EMTs, dispatchers and EODTs personnel, many of whom are veterans eligible for VFW membership. CONDUCT A VETERAN'S DAY PROGRAM ON NOV. 11. Organize a community event on Veterans Day honoring all veterans. For a ceremonial procedure, refer to the information found in the VFW Community Activities and Citizenship Education VFW Chairperson's Guide. HALF-STAFF U.S. FLAG ON DEC. 7. Public Law 103-308, passed in 1994, designates Dec. 7 as "National Pearl Harbor Remembrance Day" and requests the flag of the United States to be flown at half-staff (sunrise to sunset) in honor of the individuals who lost their lives on that day. To order a flag, go to vfwstore.org/category/flags/usflags.

"UPDATED" POW/MIA FLAG -- OFFICIAL DISPLAY DAYS. Under previous Public Law 105-85 (Nov. 16, 1997), it indicated there were only six days that federal agencies, military installations and U.S. post offices were required to display the POW/MIA flag. Now under new law, Public Law 116-67 (Feb. 21, 2020), it is required that the POW/MIA flag be flown on all days on which the flag of the United States is displayed. To purchase a POW/MIA flag, go to wfwstore.org/products/GP237.

IRS AND VFW AWARD MONIES. The Internal Revenue Service (IRS) requires that any recipient that receives more than a \$599 award should receive a Form 1099 identifying the proceeds as taxable. This will include the VFW programs Patriot's Pen and Smart/Maher VFW National Citizenship Education Teacher Award.

VFW Member Benefits

Don't Get Stuck with Costly Medical Bills.

If you are a veteran and have TRICARE insurance coverage, you still may be on the hook for out-of-pocket health care expenses. As of 2023, TRICARE Select now has a YEARLY catastrophic cap of \$4,028 — that can be a lot to pay each year.

"Buddy"® Poppy

"BUDDY" POPPY CAMPAIGN. Although we emphasize Buddy Poppies on Veterans Day and Memorial Day, it is important to realize that the distribution of Buddy Poppies should be a year-round exercise. Each time a Post participates in an activity where the public will be present, Buddy Poppies should be present as a fundraising tool and simply to recognize our fallen comrades. Where the VFW appears, Buddy Poppies should be a constant reminder that we will never forget those who have perished in the name of liberty. Just as "They Gave, Will You?" is a year-round thing, so should the distribution of VFW Buddy Poppies.

Remember that your poppies should be ordered a minimum of three (3) weeks in advance of your distribution date.

BUDDY POPPY UPDATE: National Headquarters conducted a review of the Buddy Poppy policy and procedures and implemented the following changes effective Aug. 1, 2023:

- Departments must order poppies through OMS.
- All poppies are shipped within 10 days of ordering except orders placed in June and July, due to preparation for National Convention, please allow an additional five business days.
- All orders for the traditional Buddy Poppy, Anniversary Poppies or tin tab Poppies must be placed through your Department Headquarters. Auxiliaries must go through their Post to order all poppies.
- 4) The tabs do count towards the Buddy Poppy requirement for the All-American program.
- If you do not receive your order within four weeks of placing it with your Department, please contact your Department Headquarters to report you have not received your order.
- 6) If you do not report a missing order within 90 days of processing, the order will NOT be replaced free of charge, and you will have to resubmit your order.

Miscellaneous items (coin cans, buttons, posters, etc.) should be ordered directly from the VFW Store at wfwstore.org/category/programs/buddypoppy or the VFW Store/Emblem and Supply Catalog.

The Manual of Procedure provides that Post relief funds may be used for programs such as Voice of Democracy, Patriot's Pen, Citizenship Education, and Community Service as long as suggestions in the chairperson's guidebooks are used as an example of promoting these programs.

Posts are further reminded that Section 711 of the Manual of Procedure provides that non-profit organizations, exempt from taxes under Section 501(a) of the Internal Revenue Code, may assist with the distribution of Buddy Poppies, provided there shall be no division of proceeds. A donation to these groups may be made from the Post general fund.

VFW SILVER, GOLD AND DIAMOND ANNIVERSARY POPPIES. The silver, gold and diamond anniversary Buddy Poppies are for Posts that are currently in their 25th, 50th or 75th anniversary years. For Posts currently in their 100th year anniversary, they can order any color and as many as they need. Please limit your order of anniversary poppies to 1,000 to ensure stock does not run out unless you are currently in your 100th year. These are ordered through the Department in OMS and processed the same as the red poppies. Currently we have no plans to replenish inventory due to increased cost and the small quantities we sell of the Anniversary Poppies. Based on the past four years sales, we have sufficient inventory for the next 3.5 years of the Gold, 5 years of Diamond and 52 years of the Silver.


Your Voice on Capitol Hill
