## PROPOSED DEPARTMENT BYLAW CHANGES

The Department has proposed important changes to the Department's bylaws aimed at improving operations and clarifying procedures. These changes include increasing the new member fee from \$2 to \$5 and raising Department Convention registration fees from \$5 to \$10 for both delegates and leadership attendees. These updates will help the Department more effectively support operations and event planning in today's evolving budgetary needs.

Legislative Report May 2025**

These are the key Topics from this month. Please read through these and let me know your thoughts on how we can continue to show Louisiana, that our Elected Officials are committed to our Veterans.

April 7th:

VFW Joins Maryland Governor's Veteran Roundtable: VFW Washington Office Executive Director Ryan Gallucci and VFW Department of Maryland Commander Joe Cicchillo met with Maryland Governor Wes Moore and other members of the veterans' community for a roundtable discussion on key policy issues. Gallucci and Cicchillo are both residents of the state who offered the governor and his team insights regarding challenges facing Maryland veterans, such as accessing earned care and benefits. They also provided an update on the VFW's efforts to fight Claim Sharks at both the state and federal levels, and explained the VFW's "Honor the Contract" rallying cry, which calls on our nation's leaders to meet the contractual obligation of caring for those who served in uniform.

April is Sexual Assault Awareness Month: Military sexual trauma (MST) relates to sexual assault or harassment that occurred during military service. Although VA is spotlighting MST education and treatment this month, it works year-round to raise awareness of its resources to address this issue. Learn more and explore VA's MST resources.

Get the Facts on Toxic Exposure Screenings: VA has conducted toxic exposure screenings for millions of veterans since the passage of the Honoring our PACT Act of 2022 (Public Law 117-168). However, myths persist regarding the law's purpose and scope, such as only older veterans are eligible for screening. To rebut common misconceptions, VA provides myth- or-fact clarification, as well as links to additional information resources. Read more.

April 14th:

VFW Joins Domestic Military Toxic Exposures Roundtable: House Committee on Veterans' Affairs Ranking Member Mark Takano (CA-39) convened a roundtable with more than a dozen veteran organizations and advocacy groups to discuss toxic exposures on and around domestic military bases. VFW National Legislative Associate Director Nancy Springer shared insights on military firefighter exposure to per- and polyfluoroalkyl substances (PFAS), which stem from the use of aqueous film forming foam to extinguish fuel fires. She also stressed the need for Congress to carefully monitor the VA Presumption Decision Process that systematically evaluates presumptive conditions of service connection. Watch the roundtable.

VFW Testimony for House Subcommittee Hearing: VFW National Legislative Associate Director Nancy Springer provided a statement for the record for a House Veterans' Affairs Subcommittee on Disability Assistance and Memorial Affairs hearing on VA's efforts to decrease delays in processing claims. Springer explained that not fully evaluating a claimant's record and requiring unnecessary examinations or medical reviews causes delays. VA highlighted how its improved automated tools and enhanced training programs are accelerating the claims process. Read the testimony or watch the hearing.

**House Passes Six Veteran Bills:** The House passed six bipartisan bills for veterans and their families. The VFW recently testified in support of H.R. 1039, Clear Communication for Veterans Claims Act, that would simplify VA notice letters to make them more understandable to recipients; and H.R. 1228, Prioritizing Veterans' Survivors Act, that would move the Office of Survivors Assistance to the Office of the Secretary to ensure prioritization of all survivor benefits. The VFW has supported the other bills in the previous Congress, and we will continue to monitor their progress. [Read more.](#)

**VetServe 2025:** VA will join in celebrating National Volunteer Week that takes place this year from April 20–26. As part of its VetServe 2025 campaign, VA's National Day of Service on April 23 will focus on strengthening the capacity of volunteers and highlighting their positive impact. Volunteers have made tremendous contributions to our nation's service members, veterans, and their families. This day is an opportunity across all 50 states to make a difference in the lives of those who have served.

**April 21st:**

**VFW Meets with White House Officials:** VFW Washington Office Executive Director Ryan Gallucci and National Legislative Director Kristina Keenan met with members of the White House Office of Public Liaison to introduce our organization's goals, history, and legislative priorities. The discussion centered around the Administration's plans to organize meaningful events and roundtables to hear directly from veterans, and to find ways to promote their health and wellness.

**VFW Senior Vice Commander Conference:** The VFW held its annual three-day training conference in Kansas City, Mo., to prepare Department Senior Vice Commanders for their upcoming command year. Attendees received briefings from various business lines of the organization. VFW National Legislative Director Kristina Keenan provided information about the VFW's current legislative priorities and how to encourage participation from our members. A primary recommendation is to stay informed about legislative activism through the VFW Action Corps Weekly and periodic Action Alerts. Keenan encouraged these future commanders to invite all veteran supporters in their communities to join the VFW Action Corps.

**VA Contact Centers Migrating to Cloud:** VA is enhancing its contact centers, such as the Women Veterans Call Center and Veterans Crisis Line, by migrating to a modern cloud platform. This upgrade aims to provide veterans with faster and more personalized support. Launched in March 2025, the new system features scalable tools, AI-driven insights, and real-time responsiveness. **Reinstatement Opportunity for COVID-19 Discharges:** In accordance with a presidential executive order, DOD is offering reinstatement with back pay and benefits to over 8,000 former active and reserve service members who were discharged solely for refusing the COVID-19 vaccine, and request to return. The military services are directly contacting these individuals to ensure they are informed of the opportunity available through April 1, 2026. [Read more.](#)



April 28th:

**VA Announces May 1 End to Home Loan Relief Program:** On April 23, VA announced it will stop accepting submissions to the Veterans Affairs Servicing Purchase (VASP) program effective May 1, 2025. This includes any new VASP Trial Payment Plans (TPPs), where borrowers demonstrate the ability to make their new monthly payments for three months before the loan is fully modified. However, active TPPs will continue through Aug. 31, 2025. If you are facing foreclosure on a VA-guaranteed home loan, speak to your lender before May 1. [Read more.](#)

**Protecting Veterans from Bad Actors:** Con artists often target veterans who receive significant VA benefits, such as Purple Heart recipients and those eligible for Special Monthly Compensation, specially adapted housing grants, or VA pensions. Common scams include identity theft, fraudulent investment schemes, and fake financial services that mimic legitimate free offerings. You can protect yourself by never sharing your VA account details and by authorizing benefits deposits only into bank accounts in your own name. Suspected fraud should be immediately reported to VA at 800.827.1000. [Learn more.](#)

**VA Program Helps Veterans Manage Their Benefits:** VA's Fiduciary Program protects veterans who are unable to manage their own VA benefits due to illness, injury, or age. If medical documentation or a court establishes incompetence, VA will assign a fiduciary who is usually a family member or friend selected by the veteran. This individual must then undergo an investigation to determine suitability. Veterans may appeal VA's determination of incompetence or its selection of a fiduciary. [Learn more.](#)

## Proposed Bylaws Amendment 25.002

Description from Submitter: Amend Article 5, Section 3A, *Department Convention Registration Fees*: by changing the delegate registration fee from five dollars (\$5.00) to ten dollars (\$10.00).

Current Bylaws Content:

- A. In accordance with Section 222 National Bylaws, a delegate registration fee of five dollars (\$5.00) shall be paid by each Post for each and every delegate to which the Post shall be entitled based upon transmittal reports and dues covering the membership of the Post as received by the Department Quartermaster as of March 31st with such additions as may be necessary by new Posts only.

**Proposed Amended Bylaws Content:**

- A. In accordance with Section 222 National Bylaws, a delegate registration fee of ten dollars (\$10.00) shall be paid by each Post for each and every delegate to which the Post shall be entitled based upon transmittal reports and dues covering the membership of the Post as received by the Department Quartermaster as of March 31st with such additions as may be necessary by new Posts only.**

Proposed Bylaws Amendment 25.003

Submitted by: PSC Ray Bass (current Department Quartermaster)

Description from Submitter: Amend Section 3C, *Department Convention Registration Fees* by changing the described fee from \$5.00 to \$10.00.

Current Bylaws Content:

- C. A registration fee of five dollars (\$5.00) shall be paid by each and every Past Commander-in-Chief, Department Officer, Past Department Commander, District Commander and Post Commander; comprising the composition of the Department Convention on or before registering as a member of the Department Convention.

**Proposed Amended Bylaws Content:**

- C. A registration fee of ten dollars (\$10.00) shall be paid by each Past Commander-in-Chief, Department Officer, Past Department Commander, District Commander and Post Commander; comprising the composition of the Department Convention on or before registering as a member of the Department Convention.**

Description from Submitter: Amend Article 9, Section 1: *Council of Administration Meetings* by removing two council seats and adding one additional seat. Currently there are 21 voting members on the Department's Council of Administration. Currently three are appointed by the Department Commander. If the Department Commander appoints an already elected member of the council it will decrease the voting power of the council and possibly cause time delaying votes with ties. This would REMOVE the State Chief of Staff and the State Inspector as sitting members of the Council of Administration.

The addition of one additional Past Department Commander will be added as a voting members of the Department's Council of Administration if needed. To create an odd number for voting to avoid a tie.

Current Bylaws Content:

## ARTICLE IX

### Council of Administration Meetings

#### Sec 1, Composition

The Council of Administration shall consist of the following elected officers, Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster, Judge Advocate, Surgeon, Chaplain. Additionally, the following appointed officers shall serve as members of the Council of Administration, Adjutant, Chief of Staff, and Inspector. District Commanders, shall serve on the Council of Administration and in the absence of a District Commander, the District Senior Vice Commander, and in the absence of the Senior Vice Commander, the District Junior Vice Commander may function as a member of the Council of Administration. The retiring Department Commander shall also be member of the Council of Administration. In the event a Past Department Commander is unwilling or unable to serve on the Council of Administration, their place shall be filled by the last retiring Past Department Commander who is ready, willing and able to serve.

**Proposed Amended Bylaws Content:**

## ARTICLE IX

### Council of Administration Meetings

#### Sec. 1. Composition

**The Council of Administration shall consist of the following elected officers: Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster, Judge Advocate, Surgeon, and Chaplain. *If the Department Commander has appointed an Adjutant not also serving as the elected Quartermaster, the appointed Adjutant shall serve as a member of the Council of Administration.* District Commanders shall serve on the Council of Administration and in the absence of a District Commander, the District Senior Vice Commander, and in the absence of the Senior Vice Commander, the District Junior Vice Commander, may function as a member of the Council of Administration. *If the State Quartermaster and State Adjutant are the same person, decreasing the voting strength of the council from 19 votes to 18 votes, the previous Department Commander who preceded the Junior Past State Commander in office shall be added as a member of the Council of Administration. If a Past Department Commander is unwilling or unable to serve on the Council of Administration, their place shall be filled by the next previous Past Department Commander who is ready, willing and able to serve.***

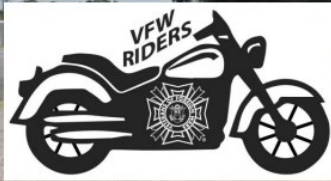
